

RICHARD M. BIRNIB

I, RICHARD M. BIRNIE, of the County of Los Angeles, State of California, being of lawful age and of sound and disposing mind and memory, and not acting under duress, menace, fraud or the undue influence of any person whomsoever, do hereby make, publish and declare this my Last Will and Testament, and do hereby expressly revoke all former Wills and Codicils to Wills by me made, in the manner following:

ARTICLE I

I hereby declare that I am married and that my spouse is VERITA L. BIRWIE. I declare that my said spouse is sometimes hereinafter referred to as my "spouse", and that I have the following children from a previous marriage, to wit:

CAMERON S. BIRNIE ROBIN E. BIRNIE ALLISON L. BIRNIE

I hereby declare that I have no children from my marriage to VERITA L. BIRNIE.

ARTICLE II

I give and bequeath to my spouse all articles of household use, including furniture, books, pictures, silverware and linen. If she shall predecease me, then such gifts shall lapse and fall into the residue.

ARTICLE III

I give, devise and bequeath all of the rest, residue and remainder of my estate, real and personal, wherever situated to my children then living, share and share alike.
