18	Attached or submitted to you as Exhibit 1 is
19	an affidavit of the landman setting forth all the matters

22	about one half of one percent interest in the well unit.
23	There are two locatable owners, Chester Stuebben
24	and Sandy Wische, and they have been mailed by certified

2	There are three unlocatable owners, Larry Turner,
3	John McIsaac and Alan Tuck and Mrs. Evelyn Tuck. Applicant
4	has been unable to locate them, and a statement regarding
5	the attempts made to locate them are included in the
6	affidavit.
7	The correspondence sent to the parties is
8	submitted with the affidavit, together with the authorities
9	for expenditure for the well and a statement as to the
10	requested overhead rates.
11	Also submitted as Exhibit 3 is a copy of the
12	notice published in the newspaper with respect to these
13	interest owners since they are several were unlocatable.
14	So I would move the admission of Exhibits 1, 2
15	and 3.
16	And again, this case was advertised that in the
17	absence of objection it will be taken under advisement.
18	EXAMINER EZEANYIM: There being no objection,
19	Exhibit Number 1 through 3 will be admitted into evidence.
20	This well is yet to be drilled, right?
21	MR. BRUCE: These wells have been drilled, Mr.

BRUCE: One was drilled about a year and a 3 half ago, and one was late last year. 4 EXAMINER EZEANYIM: So what are they doing now? 5 This is now shut in? 6 MR. BRUCE: Both wells are producing. There is 7 one well in each quarter section under Division Rules. 8 EXAMINER EZEANYIM: Yeah. 9 MR. BRUCE: Both are producing from the Morrow 10 11 currently. I'm looking for -- oh, here EXAMINER EZEANYIM: 12 13 it is. Is the AFE here too? 14 MR. BRUCE: They should be right at the very end 15 of Exhibit 1, Mr. Examiner. 16 EXAMINER EZEANYIM: Kind of hard to read, but 17 that's okay. What overhead rates are you asking for in this 18 19 case? MR. BRUCE: \$7000 a month for a drilling well and 20 \$700 a month for a producing well. 21 22 EXAMINER EZEANYIM: And this well was drilled in 23 that area? 24 MR.
