PARTICIPATING AREA 2004 REVIEW

Thirty (30) Fruitland Coal Wells were cleaned out in 2004.

Devon installed additional wellhead compression on nineteen (19) conventional wells.

All lands in the Northeast Blanco Unit are included in the Blanco Mesaverde Pool and the Basin Fruitland Coal Pool Expanded Participating Areas. Because these participating areas are fully expanded, no revisions were made in 2004. We have enclosed a plat of the Northeast Blanco Unit showing the current participating areas.

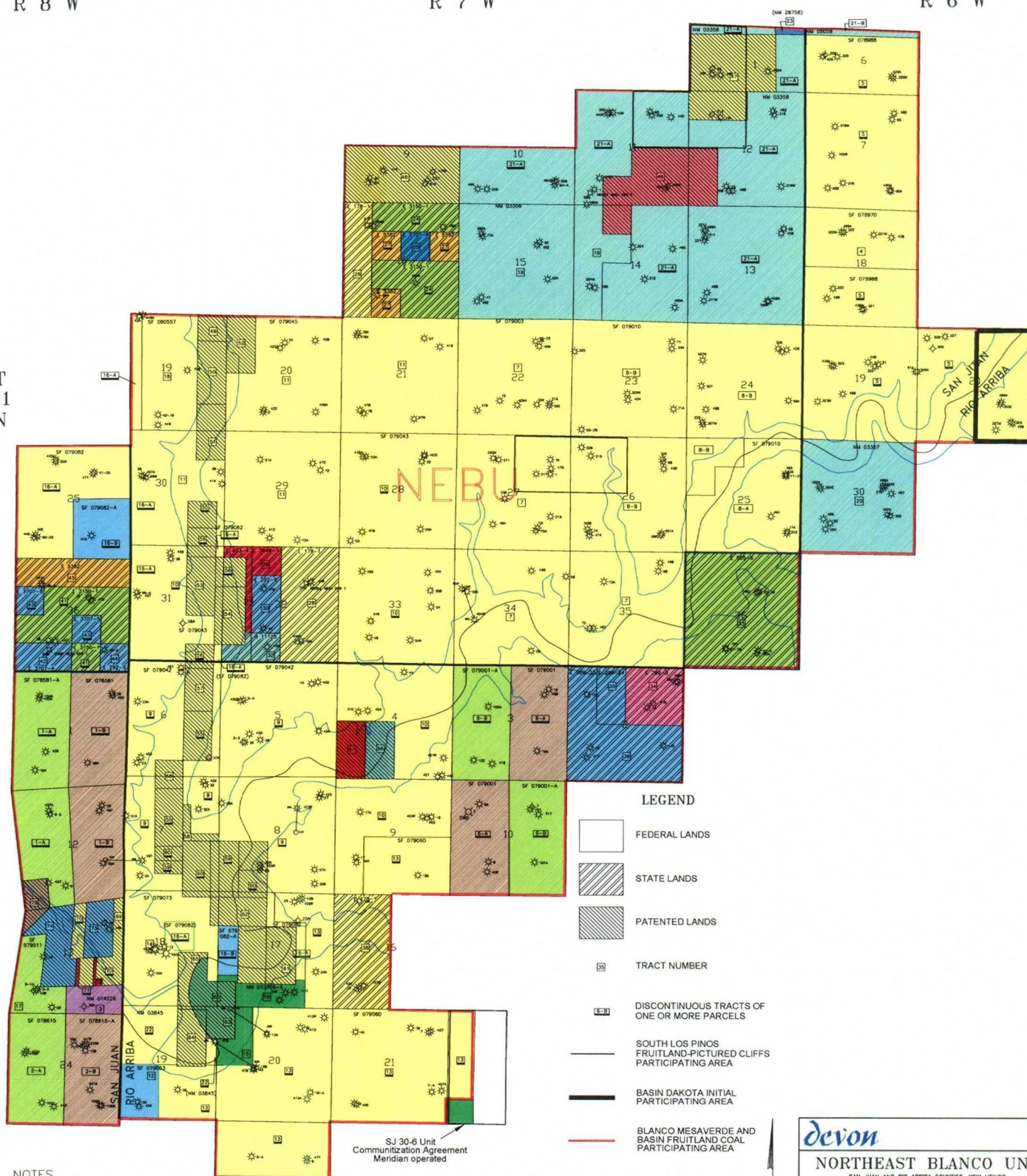
