**APPLICANT'S STATEMENT OF CASE**

COG Operating LLC seeks an order: (1) creating a non-standard, 160-acre spacing and proration unit comprised of the W/2 E/2 of Section 9, Township 19 South, Range 26 East, NMPM, Eddy County, New Mexico; and (2) pooling all mineral interests in the Glorieta-Yeso formation underlying this acreage. This proposed non-standard spacing and proration unit will be the project area for the Stonewall 9 Fee No. 3H well to be horizontally drilled from a surface

location in the SW/4 SE/4 (Unit O) to a bottom hole location in the NW/4 NE/4 (Unit B) of Section 9. The completed interval for this well will remain within the 330-foot standard offset required by Division rules.


