12 MR. FELDEWERT: Mr. Examiner, with respect
13 to page 2, Case 15051 --

14 EXAMINER GOETZE: Yes.

15 MR. FELDEWERT: -- I'd ask that that case
16 be called so I can make a statement. There is a party
17 that is involved, who we had a notice issue with, that
18 they've been able to reach an agreement with, and we can
19 now dismiss them from the pooling application. But I
20 think the case probably needs to be called, so I can
21 make that statement.

22 EXAMINER GOETZE: Very good.

23 EXAMINER BROOKS: Yeah. And I think it
24 will not be continued.

25 Mr. FELDEWERT: Right.

1 EXAMINER BROOKS: I discussed this with
2 Mr. Feldewert, and since no other party is represented
3 by counsel, it was not an ex-parte conversation, at
4 least not under the terms of the OCD's ex-parte rule.

5 MR. FELDEWERT: Agreed.

6 EXAMINER GOETZE: Very well. Then we will
7 go ahead and hear Case 15051.
