WPX seeks an order (1) creating a non-standard 160-acre spacing and proration unit comprised of the S/2 N/2 of Section 9, Township 23 North, Range 8 West, NMPM, San Juan

County, New Mexico; and (2) pooling all mineral interests in the Mancos formation, Nageezi Gallup Oil Pool, underlying this acreage. WPX proposes to dedicate the above-referenced spacing and proration unit as the project area for its Chaco 2308-09A 146H well.
