WPX Energy Production, LLC ("WPX") seeks an order authorizing a non-standard spacing and proration unit in the N/2N/2 of Section 9, Township 23 North, Range 8 West, N.M.P.M. for its proposed Chaco 2308-09A 145H Well that will have a surface location 240 feet from the East line of Section 9, potentially encroaching on the acreage to the East in Section 10, T23N, R8W. WPX's application does not describe a point of penetration of its proposed well into the Mancos formation, Nageezi Gallup Oil Pool. Encana Oil & Gas (USA), Inc. ("Encana") owns 100%

of the working interest in Section 10, T23N, R8W and Encana opposes WPX's application for the following reasons:

 If WPX's proposed Chaco 2308-09A 145H Well penetrates the Mancos formation, Nageezi Gallup Oil Pool within 330 feet of the East line of Section 9, it will encroach on and drain from Encana's acreage in Section 10, Township 23 North, Range 8 West, infringing on Encana's correlative rights.
