**Note #1:** This report is based on a list of mineral owners provided by Paul Lehrman of XTO Energy Inc. purporting to cover leased and unleased interests for the N2 of Section 17, T29N R14W. No legal descriptions were provided with the names. All the names on said list were entered into the grantor/grantee index at the San Juan County clerk's office for possible change of ownership since Jan 1, 2004, or a date prior to the last series of recorded oil and gas leases covering the subject lands. A check of the New Mexico state production records indicates that there were no leases held by production from previous leases to those taken in 2004. Oil and gas leasehold ownership is based on leases found in the tract index of the San Juan County Abstract and Title Company, Farmington NM with a plant date of Jan. 7, 2013.

**Note #2:** Without legal descriptions of the unleased interests, It was difficult to know if a deed or conveyance out of an unleased owner conveyed all of his/her interest or just part of his/her interest. For the purpose of this report, all unleased owners that appear to have conveyed an interest, are still listed as a mineral owner even though it is possible that all of their mineral interest was conveyed.

This report was made solely for the purpose of assisting in the determination of the apparent mineral and leasehold ownership of the captioned lands and limited to the sources quoted therein. The instruments involved have not been examined to determine their legal sufficiency and no warranty of title is expressed or implied by virtue of the information contained herein.
