

Is that satisfactory to who 5 you're representing? 6 MR. PADILLA: Is it and it isn't. 7 And I hate to -- I quess if I have to be on the side of 8 representing my client, I would say it would not be the 9 10 same, reading a transcript. EXAMINER GOETZE: Okay. Very good. 11 Now we'll go back to Mr. Larson. 12 And, Mr. Feldewert, your name was brought 13 14 up in this context. MR. LARSON: Mr. Examiner, we assume that 15 16 Mr. Feldewert will be stepping in in my stead as counsel for Yates. Obviously, the best circumstance to Yates 17 18 would be having the case continued. Their witnesses are here, but based on the understanding between Mr. Bruce 19 and Mr. Padilla, Yates was going to put on its case in 20 two weeks anyway. So from our perspective, the best 21 solution is to continue. 2.2 23 EXAMINER GOETZE: So I have a lawyer with 24 no witnesses. I have witnesses with no lawyer. Page 7 (Laughter.) 1 2 MR. BRUCE: Nobody said it would be easy, 3 Mr. Examiner. EXAMINER GOETZE: I know. It's easier when 4 it is just an objection. Huh. 5 And your clients, with respect to them, the 6 inconvenience to them for two weeks? 7 MR. BRUCE: Two weeks. They've made the 8 9 trip up. My primary witness, Mr. Huber, is not an employee of Owl. He has another job. He's a 10 contract -- you know, he's a consultant for this case, 11 and so it is an inconvenience to them. 12 EXAMINER GOETZE: Well, this puts us in a 13 14 peculiar situation. As the process requires, we do offer the ability for each of these participant 15 protestants to be able to cross, and I feel at this time 16 17 that with two parties half present, we really can't move 18 forward with the opportunity to have presentation and have good cross-examination or interviews of the 19 20 witnesses. So at this point, I don't see how I can go on forward with this case and would ask that it be 21 22 extended to the next hearing. And you may take it up with the Commissioner or Director, but we do have to 23 have the opportunity for witnesses and counsel to be 24 25 present.

Page 8 MR. BRUCE: If that's the case, 1 2 Mr. Examiner, we'll -- you know, we accept your ruling. I will have to talk with my clients. I would ask that 3 it only be continued two weeks, but I need to check with 4 5 them. EXAMINER GOETZE: We will make it two 6 7 weeks, and that's it. If you don't show up in two weeks -- you've had the opportunity to have all these 8 problems resolved, and at that point, everyone's going 9 It's going to go on regardless of who doesn't 10 to show. show. So let's go with that. 11 So at this point, we will take Case 15060 12 and continue it to the January 23rd hearing, and at that 13 point, we would request that everybody show up that's 14 involved with this case. And if there are problems with 15 your witnesses, we will take into consideration your 16 17 having your witnesses' appearance as a primary driving force of this. In other words, you will have the say in 18 19 this. The folks on the other side, the 20 protestants, gather everything up and make sure you're 21 ready for the 23rd. All right? 22 MR. PADILLA: All right. 23 EXAMINER GOETZE: And that's the end of the 24 25 hearing.
