APPLICANT: Endurance Resource, LLC, seeks approval for an order pooling all mineral interests from the surface of the earth to a depth sufficient to test the Bone Springs Formation (Bell Lake Bone Spring, North Pool, No. 5150), non-standard spacing and proration unit underlying the E/2 of Section 18, Township 23 South, Range 34 East, NMPM, Lea County, New Mexico. Applicant intends to drill its Starcaster 18 Federal 4H well to be located at a standard well location having as surface location 330 FNL and 660 FEL of Section 18 and a bottom hole location of 330 FSL and 660 FEL of said Section 18.
