Greetings! I believe we submitted a letter requesting that this case be continued to the February 20th docket. I think that Mike may have requested February 6, but was unaware that we had already asked for February 20. Our preference would be for February 20. The parties are very close to reaching agreement but probably need that extra time. If we do have to go to hearing it is our intention to dismiss from the hearing portion of the case the part of the application that is being addressed by the administrative application.

Mike,

Attached please find a copy of the above-referenced application that was filed with the Division today. We also re-noticed today all the parties identified in Exhibit D to the original application due to the change in the proposed bottom hole location and the well bore's completed interval.

As provided for in the amended application the completed interval for this well bore will be at a location between 330 feet from the West line and 380 from the south line and 380 feet from the East line and 380 feet from the South line Section 16 of Township 23 North, Range 8 West, NMPM, San Juan County.


As provided for in the rules, the Division may approve this application 20 days after receipt if no parties object. Because WPX has a rig scheduling issue it is requesting that review of this application be expedited and, if no objections are received, approved upon the day that it is ripe for review. The Division received the application today so by my calculation the application is ripe for review and approval on February 13, assuming no parties object.
