Re: <u>Birddog 19 State #1H (AFE #13106)</u> Surface Location: 225' FSL & 1980' FEL Section 19, T21S-R34E, N.M.P.M. Lea County, New Mexico

Gentlemen:

A check of the records of Lea County, New Mexico, reflects that EOG Resources, Inc. is the owner of the W/2NE/4 and SE/4NE/4 of Section 19. Elevation proposes the creation of a drilling unit comprised of the E/2 of Section 19.

On or before May 1, 2014, Elevation Resources LLC ("Elevation") proposes to drill the Birddog 19 State #1H. The objective of the well will be to attempt a completion as either a horizontal 2<sup>nd</sup> or 3<sup>rd</sup> Bone Spring Sand well. The well is to be drilled to approximately 11,800' TVD/MD. The total cost of the operation is estimated to be \$8,567,050.00. A detailed description of the cost estimate is set out in the accompanying Authorization for Expenditure.

Elevation proposes the well to be drilled at a surface location of 225' FSL & 1980' FEL of Section 19, with a bottom hole location of 330' FNL & 1980' FEL of Section 19, both in T21S-R34E, N.M.P.M., Lea County, New Mexico.

Please advise within thirty (30) days from receipt of this letter whether or not you wish to participate in the proposed operation. If you wish to participate in the drilling of this well, please execute the AFE and one copy of this letter and return to my attention. Upon receipt of a copy of this letter noting your desire to participate in the well, Elevation will forward to you its proposed form of JOA for your consideration. Should you elect not to participate, we ask that you consider a farmout to Elevation of your acreage in the NE/4 of Section 19 under mutually acceptable terms.
