2 COMMISSIONER CATANACH: Good morning. This
3 is a meeting of the New Mexico Oil Conservation
4 Commission. My name is David Catanach, Chairman of the
5 Commission. The time is about 9:02 a.m. And today's
6 date is December 10th, 2015. This meeting is being
7 conducted in Porter Hall within the Wendell Chino State
8 Building.

9 At this time, I will take roll. Will the
10 Commissioners please introduce themselves for the
11 record.

12 COMMISSIONER PADILLA: Patrick Padilla,
13 designee of the Commissioner of Public Lands.

14 COMMISSIONER BALCH: Robert Balch, designee
15 of the Secretary of Energy and Minerals.

16 COMMISSIONER CATANACH: Thank you. Also
17 present today is Bill Brancard, the general counsel for
18 the department and commission attorney.

19 Commissioners, in your packet you should
20 have an agenda for today's meeting. After you've
21 examined this, can I get a motion to adopt the agenda
22 for today?

23 COMMISSIONER PADILLA: So moved.

24 COMMISSIONER BALCH: And seconded.

25 COMMISSIONER CATANACH: All in favor.

1 COMMISSIONER PADILLA: Aye.

2 COMMISSIONER BALCH: Aye.

3 COMMISSIONER CATANACH: Aye.

4 Motion to adopt today's agenda is passed.

5 Also in your packets are the draft minutes

6 from the November 5th, 2015, Commission Meeting.

7 Commissioners, if you've reviewed these, do you have any
8 changes to the minutes?

9 COMMISSIONER BALCH: I've reviewed them. I
10 have no changes.

11 COMMISSIONER PADILLA: Likewise, I have no
12 changes.

13 COMMISSIONER CATANACH: Okay. Do I hear a
14 motion to adopt the minutes from the November 5th, 2015,
15 Commission Meeting?

16 COMMISSIONER BALCH: I'll so move.

17 COMMISSIONER PADILLA: And I second.

18 COMMISSIONER CATANACH: All in favor.

19 COMMISSIONER BALCH: Aye.

20 COMMISSIONER PADILLA: Aye.

21 COMMISSIONER CATANACH: Aye.

22 Tell you what, I think what we will do is
23 call the continuances. There were some cases on the
24 docket for today that have been continued. I will go
25 ahead and call those just for the record.

1 Case No. 15281, case No. 15282,
2 case No. 15283, which are all three basically the same
3 type of application, the application of COG Operating,
4 LLC, for a nonstandard spacing and proration unit and
5 compulsory pooling, all three of these cases have been
6 continued to the February 11th, 2016, Commission
7 meeting.

8 Also on the docket is case No. 15322, which
9 is the Application of Key Energy Services, LLC, for
10 approval of a salt water disposal well, Eddy County, New
11 Mexico. This case has been continued to the
12 January 14th, 2016, Commission meeting.

13 So the next order of business today is to
14 review two drafts of the order in case No. 15327, which
15 was heard by the Commission on November 15th.

16 We have received a draft order from the
17 Applicant in that case, COG Operating, and we've also
18 received a draft order from the Oil Conservation
19 Division, and we distributed those orders to the
20 Commissioners.

21 And I would ask the Commission, is it the
22 pleasure of the Commission to review amended, finalized
23 as draft order in open session or in executive
24 session?

25 COMMISSIONER BALCH: I'm for executive

1 session.

2 COMMISSIONER CATANACH: Okay. Do I hear a
3 motion to go into executive session to review the
4 orders?

5 COMMISSIONER PADILLA: I would move that we
6 go into executive session to review the orders.

7 COMMISSIONER BALCH: And I will second that.

8 COMMISSIONER CATANACH: All in favor.

9 COMMISSIONER PADILLA: Aye.

10 COMMISSIONER BALCH: Aye.

11 COMMISSIONER CATANACH: Aye.

12 So at this time we will go into executive
13 session to consider the draft orders in this case.

14 (Whereupon, the Commissioners Reviewed the
15 Orders in Executive Session.)

5 executive session, we discussed the draft orders
6 submitted by the OCD and by COG in case No. 15327. And
7 we have come to an agreement as to what the order will
8 say and the revisions that we have will be done by
9 Mr. Brancard.

10 That probably will take 30 to 60 minutes to
11 make the revisions, and we will probably sign the order
12 at that time when the revisions are done and the order
13 prepared. If you guys want to stick around, you can,
14 or, if not, we can just get you a copy of the order.

15 MR. FELDEWERT: That would be great.

16 COMMISSIONER CATANACH: Mr. Feldewert did
17 make a note that I did not call case No. 15105, which
18 was also an application by COG on this docket.

19 Just for the record, this case will also be
20 continued to the February 11th, 2016, Commission
21 meeting.

22 Is there anything else, Commissioners, that
23 we need to address?

24 MR. BRANCARD: Mr. Chairman, do you want to
25 adopt the order based on your discussions? And then you

1 can close the meeting and just sign it whenever it is
2 ready. Don't have to go back into open session to sign
3 it.

4 COMMISSIONER BALCH: I would make a motion
5 to adopt the order as we agreed to and to then adjourn.

6 COMMISSIONER PADILLA: I second that.

7 COMMISSIONER CATANACH: All in favor.

8 COMMISSIONER PADILLA: Aye.

9 COMMISSIONER BALCH: Aye.

10 COMMISSIONER CATANACH: Aye.

11 Do I have a motion to adjourn?

12 COMMISSIONER PADILLA: So moved.

13 COMMISSIONER BALCH: And seconded.

14 COMMISSIONER CATANACH: All in favor.

15 COMMISSIONER PADILLA: Aye.

16 COMMISSIONER BALCH: Aye.

17 COMMISSIONER CATANACH: Aye. This

18 Commission meeting is now adjourned.
