STATEMENT OF THE CASE

In each of these three cases, OXY seeks an order (1) creating a 320-acre non-standard spacing and proration unit; and (2) pooling all uncommitted interests in the Bone Spring formation underlying each proposed unit.

In Case No. 15613, OXY seeks to create a 320-acre non-standard spacing and proration unit comprised of the E/2 E/2 of Section 26 and the E/2 E/2 of Section 35, Township 24 South, Range 29 East, NMPM, Eddy County, New Mexico. This non-standard spacing and proration

unit will be the project area for the proposed Corral Fly 35-26 Federal Com No. 26H Well, which will be horizontally drilled from a surface location in the NE/4 NE/4 (Unit A) of Section 26 to a standard bottom hole location in SE/4 SE/4 (Unit P) of Section 35.

In Case No. 15614, OXY seeks to create a 320-acre non-standard spacing and proration unit comprised of the W/2 E/2 of Section 26 and the W/2 E/2 of Section 35, Township 24 South, Range 29 East, NMPM, Eddy County, New Mexico. This non-standard spacing and proration unit will be the project area for the proposed Corral Fly 35-26 Federal Com No. 24H Well, which will be horizontally drilled from a surface location in the NW/4 NE/4 (Unit B) of Section 26 to a standard bottom hole location in SW/4 SE/4 (Unit O) of Section 35.

In Case No. 15615, OXY seeks to create a 320-acre non-standard spacing and proration unit comprised of the E/2 W/2 of Section 26 and the E/2 W/2 of Section 35, Township 24 South, Range 29 East, NMPM, Eddy County. This non-standard spacing and proration unit will be the project area for the proposed Corral Fly 35-26 Federal Com No. 23H Well, which will be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 26 to a standard bottom hole location in SE/4 SW/4 (Unit N) of Section 35.

The completed interval for each well will comply with the 330-foot standard setbacks required by Division rules for oil wells.
