19 I've submitted three exhibits to you. At
20 the original hearing, Mr. Wade was the Legal Examiner,
21 and he asked -- we had to publish notice against certain
22 people, and he wanted to know who the parties were. So
23 I simply noted on Exhibit A the parties who were -- who
24 we needed to publish notice against.

25 Exhibit B is simply Affidavit of

1 Publication from the Carlsbad newspaper against all the
2 parties we could not serve with actual notice.

3 And Exhibit C is simply my Affidavit of
4 Notice with the white and/or green cards attached
5 showing who received notice and who didn't. And the
6 landman, in the original hearing, did testify about the
7 efforts to locate all of the parties.

8 And with that, I just move the admission of
9 Exhibits A, B and C and ask that the case be taken under
10 advisement.
