**APPLICANT'S STATEMENT OF CASE**

In Case Nos. 15663 and 15664, XTO seek an order from the Division (a) creating two 320-acre spacing and proration units comprised of the W/2 W/2 of Section 8 and the W/2 W/2 of Section 17, and the E/2 W/2 of Section 8 and the E/2 W/2 of Section 17, Township 25 South, Range 29 East, NMPM, Eddy County, New Mexico; and (2) pooling all uncommitted interests in the Bone Spring formation, Willow Lake; Bone Spring, Southeast (Pool Code 96217), underlying these proposed spacing and proration units. XTO intends to dedicate the W/2 W/2 320-acre spacing and proration unit as the project area for its proposed **Corral Canyon Federal No. 13H Well**, which will be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 6 to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 17. XTO proposes to dedicate the E/2 E/2 320-acre spacing and proration unit as the project area for its proposed **Corral Canyon Federal No. 14H Well**, which will be horizontally drilled from a surface location in the SE/4 SW/4 of Section 5 (Unit N) to a bottom hole location in the SE/4 SW/4 (Unit N) of Section 17.

The Division's district office has placed this acreage in the Willow Lake; Bone Spring, Southeast (Pool Code 96217), which is subject to the general statewide rules. The completed intervals for these well will remain within the 330-foot standard offset required by the Statewide Rules.


