- 10 The first one is Case 15635. The Affidavit
- 11 of Notice to the offset operators shows that one letter
- 12 was returned to Kaye H. Gassie. So we subsequently --
- 13 it was unclaimed certified mail, so we published notice
- 14 against her. And submitted as Exhibit 12 is the
- 15 Affidavit of Publication. So in that matter, we would
- 16 move the admission of Exhibits 7 and 12 and ask that the
- 17 case be taken under advisement.

- 20 I had not received back a green card from EOG Resources,
- 21 who I believe is here today. That's the first notice
- 22 letter. So I never got a green card back even though it
- 23 shows that it was a month and a half ago that it got to
- 24 Midland. So I subsequently sent another letter to EOG
- 25 Resources. And it shows it was delivered, but I never

- 1 got a green card back.
- 2 EXAMINER GOETZE: You do have uncanny luck
- 3 with those.
- 4 MR. BRUCE: Yeah. I blame the geologist.
- 5 EXAMINER GOETZE: Thank you.
- 6 MR. BRUCE: And Exhibit 6 is simply a list
- 7 of the offset interest owners to these wells.
- 8 Exhibit 7 is an Affidavit of Notice to the
- 9 offset operators. They all received notice except,
- 10 again, for Kaye Gassie.
- 11 And Exhibit 12 is an Affidavit of
- 12 Publication against Kaye Gassie.
- So I would move the admission of Exhibits
- 14 5, 6, 7 and 12 and that the case be taken under
- 15 advisement.
- 16 EXAMINER GOETZE: Okay. In Case 15635,
