- 3 15653, application of the New Mexico Oil Conservation
- 4 Division Compliance and Enforcement Bureau for a
- 5 compliance order against Elmira T. Welch, for a well
- 6 operated in Eddy County, New Mexico.
- 7 Call for appearances.
- 8 MR. HERRMANN: Mr. Examiner, Keith Herrmann
- 9 representing the Oil Conservation Division Compliance
- 10 and Enforcement Bureau.
- 11 EXAMINER GOETZE: Any other appearances?
- 12 Very well.
- You have one witness?
- MR. HERRMANN: Yes, Mr. Daniel Sanchez.
- 15 EXAMINER GOETZE: Would you please identify
- 16 yourself to the court reporter and be sworn in?
- 17 MR. SANCHEZ: Daniel Sanchez.
- DANIEL SANCHEZ,
- 19 after having been first duly sworn under oath, was
- 20 questioned and testified as follows:
- 21 DIRECT EXAMINATION
- 22 BY MR. HERRMANN:
- Q. Mr. Sanchez, would you please state your name,
- 24 title and place of employment for the record?
- 25 A. Daniel Sanchez. I'm the Compliance and

- 1 Enforcement manager for the OCD working out of the Santa
- 2 Fe office.
- Q. And could you briefly describe the duties you
- 4 perform for the OCD?
- 5 A. I manage the district offices and oversee the
- 6 EPA UIC Program and handle all compliance and
- 7 enforcement cases that come through the OCD.
- 8 Q. Have you researched the violations detailed in
- 9 the application for hearing?
- 10 A. Yes, I have.
- 11 Q. Have you previously testified in an expert
- 12 capacity before the Oil Conservation Division?
- 13 A. Yes, I have.
- 14 MR. HERRMANN: At this moment I would like
- 15 to move to admit Mr. Sanchez as an expert witness in
- 16 compliance with the rules related to the production of
- 17 oil and gas in New Mexico.
- 18 EXAMINER GOETZE: He is so qualified.
- 19 Q. (BY MR. HERRMANN) I'll provide you with our
- 20 exhibits. Referencing OCD Exhibit 1, could you please
- identify the exhibit, the operator, the OGRID and any
- 22 persons of contact that we may have?
- 23 A. This is for the operator, Elmira T. Welch,
- 24 OGRID 1729. And I don't believe there was one listed
- 25 that was recent, at least, as contact for this operator.

- 1 Q. In what county does this operator have wells?
- 2 A. Eddy County. And it's just a single well.
- Q. Okay. Is it located outside any residential
- 4 areas or --
- 5 A. It's in a remote location.
- 6 Q. Do you recognize OCD Exhibit 2?
- 7 A. Yes, I do.
- 8 Q. Will you please identify that for the Examiner?
- 9 A. There are a couple of letters in here. One of
- 10 them was a letter that I sent out on December 27th of
- 11 2016 letting Elmira T. Welch know that they were in
- 12 violation of 19.15.5.9. That was on the inactive well,
- 13 failure to properly abandon the well.
- 14 There is also a letter from David K. Brooks
- 15 that was dated August 23rd, 2011 stating that Elmira T.
- 16 Welch was in violation of the same rule for insufficient
- 17 bonding and had requested an increase in the bonding
- 18 from \$5,000 to 7,340.
- 19 And one other letter that was in here, a
- 20 notice of violation issued through the Artesia District
- 21 Office for basically the same violations.
- Q. Inactive -- for inactivity?
- 23 A. Inactivity.
- Q. Is there also the well information in Exhibit
- 25 **2?**

- 1 A. Yes. Yes, there is.
- Q. Could you identify the well?
- 3 A. The well is the -- pronounce it right --
- 4 Cheesman #2.
- 5 Q. So just to summarize again, how many times and
- 6 when has the OCD attempted to notify the operator of
- 7 these violations?
- 8 A. Including letters of violation that went out
- 9 just recently, at least four times that I'm aware of.
- 10 O. And the dates?
- 11 A. Dates are December 27th, 2016; there was a
- 12 letter sent out, I believe, in June of 2016; the letter
- of violation that was issued in July of 2016; and the
- 14 notice on the bonding on August 23rd, 2011.
- 15 Q. And has the operator made any effort to resolve
- 16 these issues?
- 17 A. No.
- 18 Q. Overall, how many terms of Subsection A of
- 19 19.15.5.9 is Elmira T. Welch in compliance with?
- 20 A. In compliance with?
- Q. Or out of compliance. Let's go with that.
- 22 A. Financial assurance and inactive wells.
- Q. Are the well-plugging rules in place to prevent
- 24 migration of fluids, prevent waste, protect correlative
- 25 rights, and protect fresh water?

- 1 A. Yes, they are.
- Q. What's the current status of this well?
- 3 A. It is abandoned. We have been unable to
- 4 contact anyone that has taken responsibility for it.
- 5 Back in 2016, we did an inspection on the facility, and
- 6 we redid that inspection just on Tuesday, and the same
- 7 results. We have pictures of it from both time frames,
- 8 and nothing's changed in that time frame.
- 9 Q. So the well is not capable of producing?
- 10 A. No, it's not.
- 11 Q. What's the estimated plugging cost of plugging
- 12 this well?
- 13 A. This particular well, it would run about
- 14 \$35,000, based on the cost of other wells that we've
- 15 plugged.
- 16 O. And what corrective action is the Division
- 17 requesting?
- 18 A. That within -- that the OCD issue an order
- 19 allowing the Division to plug the well.
- 20 Q. All right. And were Exhibits 1 and 2 prepared
- 21 by you or under your direction?
- 22 A. Yes, they were.
- 23 MR. HERRMANN: And at this point, I would
- 24 move to admit OCD Exhibits 1 through 3, Exhibit 3 being
- 25 an Affidavit of Service provided by myself showing that

- 1 we served Ms. Welch notice of this hearing by certified
- 2 mail and also published it in the newspaper of general
- 3 circulation, Eddy County.
- And, Mr. Examiner, I apologize, but we also
- 5 served notice of this hearing to the surety, but I did
- 6 not include that in Exhibit 3 and would request that I
- 7 be given an opportunity to provide the Division with --
- 8 with that additional notice.
- 9 EXAMINER GOETZE: Well, go ahead and submit
- 10 that out of hearing. It's no issue, but let's make sure
- 11 we do get it.
- MR. HERRMANN: Yes.
- 13 EXAMINER GOETZE: So Exhibits 1 through 3
- 14 are so in the record.
- 15 (OCD Compliance and Enforcement Bureau
- 16 Exhibit Number 1 through 3 are offered and
- 17 admitted into evidence.)
- 18 EXAMINER GOETZE: Mr. Wade?
- 19 MR. WADE: The supplemental exhibit notice
- 20 to the surety, that notice was given timely?
- MR. HERRMANN: Yes.
- 22 EXAMINER WADE: No other questions.
- 23 EXAMINER GOETZE: Mr. Jones?
- 24 EXAMINER JONES: I don't have any
- 25 questions.

1 CROSS-EXAMINATION BY EXAMINER GOETZE: Just one other: There are notations here that 3 Q. at the wellhead, there are still surface issues also? There are some, yeah, what looked to be minor Α. surface issues. 6 Q. But you don't have any head or anything like that? Not that I'm aware of, not in the pictures that Α. 10 I saw. 11 Q. Thank you. 12 EXAMINER GOETZE: We have no further 13 questions for you. 14 And Case Number 15653 is taken under advisement. 15 16 So let's take a ten-minute break while we 17 get the big guns up here for the next round. 18 (Case Number 15653 concludes, 1:50 p.m.) 19 (Recess 1:50 p.m. to 1:52 p.m.) 20 21 22 23 24 25
