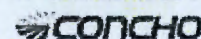

Could you please prepare a DTO/DOTO of the ownership for the SRO State Com #43H which allocates production pursuant to the SRO and Moody GX Operating Agreements?

The SRO State Com #43H covers the W/2W/2 of Sections 17 & 20, T26S, R28E.

We are looking to spud this well on or around 7/26/2014.

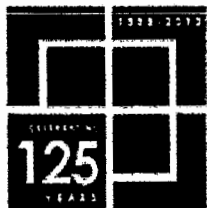

Good morning! I have tried several times to give you a call this morning, but I oddly keep getting a busy signal so I thought I would try email.

I wanted to confirm that you are working on DOTOs, both before and after the SRO unit dissolved, for the following 21 wells; the SRO State Com #1H through #20H, excluding the 19H (which doesn't exist yet), the 31H and the 53H.

You should also be working on DOTOs for the #46H and #48H effective after the SRO was dissolved: these two wells started production after the unit terminated.

I've attached a spreadsheet showing the well numbers and their sections, which I thought might be a useful reference for you.
