I have a few more COG wells that just came active that need to have signed State Comms on file, as follows:

## API 30-015-41142 - SRO State Com #44H

API 30-025-41674 – Osprey 20 State Com #4H API 30-015-42432 – Diamondback 22 State Com Well #5H

I do not see any existing Comms in these sections that cover the dedicated acreage that I can add these to, so unless you have a plan to add them to other Comms for wells that aren't completed yet, I'll need signed Comms for these wells as soon as possible. The Diamondback 5H well is in the same E2E2 as the 3H, but when I try to add it to the 3H Comm, I get an error because the 3H is producing from the Wolfcamp and the 5H is producing from the Bone Spring, and each pool has to be Communitized separately, unfortunately. Only one pool can be added to a Comm Agreement in our system,

and any wells added have to have the same pool number as the original well in the Comm.
