Page 3 1 (11:14 a.m.) 2 EXAMINER JONES: Let's go on the record and finish the last two cases of this docket. 3 4 Call Case Number 15683, application of the 5 New Mexico Oil Conservation Division Compliance and 6 Enforcement Bureau for a compliance order against Nancy 7 Wilcox E Qualls, for wells operated in Rio Arriba County, New Mexico. 8 9 Call for appearances. Mr. Examiner, Keith Herrmann 10 MR. HERRMANN: 11 appearing for the Oil Conservation Division Compliance 12 and Enforcement Bureau. EXAMINER JONES: I see there are no other 13 appearances, so you may proceed. Do you have a witness? 14 15 MR. HERRMANN: I have one witness, and I'd like to make a brief opening statement. 16 17 EXAMINER JONES: Okay. 18 MR. HERRMANN: This case is regarding our financial assurance requirements for wells operated in 19 the state of New Mexico. The operator who is the 20 21 subject of this hearing, Nancy Wilcox E Qualls, has not complied with our requirements, so we have brought this 22 to hearing to seek an order directing her to comply or 23 24 the operator to comply. 25 I have one witness, the OCD bond

Page 4 administrator, Ms. Denise Gallegos. 1 2 EXAMINER JONES: Ms. Gallegos, please 3 stand. 4 And will the court reporter swear the 5 witness? 6 DENISE GALLEGOS, 7 after having been first duly sworn under oath, was questioned and testified as follows: 8 9 EXAMINER JONES: Mr. Herrmann, can you say one more time exactly which statutes are -- rules are 10 being violated here? 11 MR. HERRMANN: Yes, Mr. Examiner. 12 It's in both my pre-hearing statement and my application for 13 hearing, but the applicable statute requiring financial 14 assurance is NMSA 1978, Section 70-2-14, and the rule 15 that was adopted pursuant to it is 19.15.8 NMAC. 16 Thank you. 17 EXAMINER JONES: DIRECT EXAMINATION 18 BY MR. HERRMANN: 19 Ms. Gallegos, would you please state your name, 20 Q. title and place of employment for the record? 21 Denise Gallegos, compliance officer with the 22 Α. Oil Conservation Division. 23 24 And could you briefly describe your duties with Q. 25 the OCD?

Page 5 Among other duties, I am responsible for the 1 Α. 2 management, enforcement and ensuring compliance of the 3 Division's assurance program. Are you familiar with the violations detailed 4 Ο. in the application for hearing? 5 6 Α. Yes. 7 Could you identify the operator that's the 0. subject of this case and their OGRID number? 8 9 Nancy Wilcox E Qualls, OGRID Number 15501. Α. 10 And in what county are these well located? Ο. Rio Arriba. Α. 11 Does the Division post all inactive wells and 12 Ο. other financial assurance information on its Web site? 13 14 Α. Yes. This is available on the OCD Web site and updated daily, on the inactive well list listing each 15 well by operator. 16 And in the state of New Mexico, does the OCD 17 Ο. require financial assurance for wells operated on state 18 and private land? 19 20 Α. Yes. And what's the amount of financial assurance 21 0. required for a well on state or private land in Rio 22 23 Arriba County? 24 Α. \$5,000, plus a dollar per foot of the measured 25 depth.

Q. And how many of the operator's wells need
 financial assurance?

- 3 A. Four.
- Q. Can you list the amount of the additional -- or
 financial assurance needed pursuant to 19.15.8.9 NMAC
 for each well? I've also provided this information in
 Exhibit 1, if you need that for reference.

So each of the wells already has a \$5,000 bond 8 Α. on file, but that's not the correct amount. 9 So the first one is C P State #1, API 30-039-05667, and the 10 bond amount should be \$7,525. The second one is C P 11 State #2, API 30-039-05236, in the amount of \$7,350; 12 C P State #3, API 30-039-05252, in the amount of \$7,350; 13 and C P State #4, API 30-039-05634, in the amount of 14 \$7,341. 15

16 Q. And that's the total amount of financial 17 assurance required?

18 A. For each well, yes.

19 Q. And this is due to a change in the rule from20 2008?

21 A. Yes.

Q. Was the operator notified of these violations,
and, if so, when?
A. Yes. I sent out a notice of financial

Page 7 and I received a signed green card on June 23rd, 2016. 1 2 As of today, I haven't received a response from the 3 operator or the requested financial assurance. Ο. And is Exhibit 2 a copy of that notice? 4 5 Α. Yes. Can you please state the relief the Division is 6 Ο. 7 requesting? Α. The Division is requesting the operator to 8 provide the OCD acceptable financial assurance within 30 9 days of issuance of an order of finding that the 10 operator is in violation of 70-2-14 of the New Mexico 11 State statutes and 19.15.8 NMAC. And if the operator 12 does not post the requested financial assurance within 13 30 days of the issuance of an order, that the operator 14 is in violation of the Division order. 15 And were Exhibits 1 and 2 prepared by you or 16 0. under your direction? 17 18 Α. Yes. MR. HERRMANN: Mr. Examiner, at this moment 19 I'd move to admit Exhibits 1, 2 and 3. Exhibit 3 was 20 not identified in testimony, but it was prepared by 21 myself. It's an Affidavit of Service of the Notice of 22 23 Hearing, including the green cards that we did receive 24 returned. 25 Exhibits 1, 2 and 3 are EXAMINER JONES:

You gave me this 0. Exhibit Number 1. So it's just included twice in here; 14 is that correct? It's included in Exhibit Number 2? 15 Right. So Exhibit 2 is what was sent to the 16 Α. 17 operator last year. 18 Thank you very much. Q. Okay. EXAMINER JONES: With that, we've heard 19 this case and we're continuing it until May the 11th. 20 21 Thank you, Mr. Examiner. MR.
