- 3 Number 15696, application of the New Mexico Oil
- 4 Conservation Division Compliance and Enforcement Bureau
- 5 for a compliance order against Norman L. Gilbreath for
- 6 wells operated in San Juan County, New Mexico.
- 7 Call for appearances.
- 8 MR. HERRMANN: Mr. Examiner, Keith Herrmann
- 9 representing the Compliance and Enforcement Bureau.
- 10 EXAMINER McMILLAN: Any other appearances?
- 11 Please proceed.
- 12 MR. HERRMANN: I would like the record to
- 13 reflect we have one witness today, Ms. Denise Gallegos,
- 14 and she has been previously sworn in OCD Case 15695.
- 15 EXAMINER McMILLAN: Please proceed.
- DENISE GALLEGOS,
- 17 after having been previously sworn under oath, was
- 18 questioned and testified as follows:
- 19 DIRECT EXAMINATION
- 20 BY MR. HERRMANN:
- Q. Ms. Gallegos, are you familiar with the
- violations detailed in this application for hearing?
- 23 A. Yes.
- 24 Q. Could you please identify the operator that is
- 25 the subject of this compliance case and the operator's

- 1 OGRID?
- A. Norman L. Gilbreath, OGRID Number 15991.
- Q. And in what county -- in what county are these
- 4 wells located?
- 5 A. San Juan and Rio Arriba Counties.
- 6 Q. I believe we're -- the violating wells are just
- 7 in Rio Arriba County; is that correct?
- 8 A. Just in San Juan.
- 9 Q. Or San Juan. Excuse me. Okay.
- 10 A. Yes.
- 11 Q. Does the Division post all inactive wells -- or
- 12 wells that are in inactive well status, or otherwise
- 13 known as temporarily abandoned status, for an operator
- 14 on its Web site?
- 15 A. Yes. This is available on OCD's Web site and
- 16 updated daily on the inactive well list, listing each
- 17 operator by well.
- 18 Q. And does the OCD require additional financial
- 19 assurance for wells that have been inactive for over two
- 20 years?
- 21 A. Yes.
- 22 O. What is that amount?
- 23 A. The amount is based on what county the well is
- located in and the measured depth of the well.
- 25 Q. How many of Norman L. Gilbreath's wells need

- 1 additional financial assurance?
- 2 A. Four.
- Q. Will you please identify those wells using
- 4 Exhibit 1 for reference?
- 5 A. The four wells that are requiring bonding
- 6 currently have a \$5,000 single well bond. So it's just
- 7 the additional amount that they're requiring.
- 8 The first one is Al Kendrick #2, API
- 9 30-045-25540, and the total bond amount should be
- 10 \$6,830;
- 11 The Emery C. Arnold #1, API 30-045-08209.
- 12 The total bond amount should be \$6,880;
- 13 R Hendrick #1, API 30-045-07784. The total
- 14 bond amount should be \$6,858;
- 15 And the Tom Baldwin #1, API 30-045-07879.
- 16 The total bond amount should be \$6,825.
- Q. Was the operator notified of these violations,
- 18 and if so, when?
- 19 A. Yes. I sent a Notice of Financial Assurance
- 20 Violation letter, certified, on June 20th, 2016. It was
- 21 returned undeliverable by the post office on June 27th,
- 22 2016. And a second Notice of Financial Assurance
- 23 Violation was mailed out, certified mail, on June 29th,
- 24 2016, and I received the green signed card back on July
- 25 13th, 2016.

1 Q. And is Exhibit 2 a copy of that notice?

- 2 A. Yes.
- 3 Q. What relief is the Division requesting?
- 4 A. The Division is requesting the operator provide
- 5 the OCD with acceptable financial assurance within 30
- 6 days of the issuance of an order of finding that the
- 7 operator is in violation of 70-2-14 of the New Mexico
- 8 state statute and 19.15.8 NMAC. And if the operator
- 9 does not post the requested financial assurance within
- 10 30 days of the issuance of an order, that the operator's
- in violation of a Division order.
- 12 Q. Is the OCD only seeking to enforce violations
- of financial assurance at this time?
- 14 A. Yes.
- 15 Q. Were Exhibits 1 and 2 prepared by you or under
- 16 your direction?
- 17 A. Yes.
- 18 MR. HERRMANN: Mr. Examiner, I have no
- 19 further questions.
- 20 If I may move to admit OCD Exhibits 1
- 21 through 3, Exhibits 1 and 2 being previously identified
- 22 during testimony, and Exhibit 3 being an Affidavit of
- 23 Service prepared by myself that includes a certified
- 24 mailing of the original date of this hearing, May 11th,
- 25 2011 [sic], and an Affidavit of Notice -- or an

- 1 Affidavit of Publication in the "Daily Times," a
- 2 newspaper of general circulation in San Juan County.
- 3 EXAMINER McMILLAN: Exhibits 1 through 3
- 4 may now be accepted be as part of the record.
- 5 (NMOCD Compliance and Enforcement Bureau
- 6 Exhibit Numbers 1 through 3 are offered and
- 7 admitted into evidence.)
- 8 MR. HERRMANN: That concludes our
- 9 presentation of OCD Case 15696.
- 10 EXAMINER BROOKS: Either you misspoke or I
- 11 misheard. I thought you said May 11th -- that this was
- 12 originally set for May 11th, 2011. So --
- MR. HERRMANN: It originally was and notice
- 14 was delivered. We've been in contact with the operator.
- 15 And through trying to deal with this outside of hearing,
- 16 we had agreed to four continuances and should have
- 17 compliance as of today, but we did not want to continue
- 18 it.
- 19 EXAMINER BROOKS: Well, my point is that it
- 20 was May 11th, 2017, right?
- 21 MR. HERRMANN: Yes. Did I say '16?
- 22 EXAMINER BROOKS: You said May 11th, 2011.
- MR. HERRMANN: Oh (laughter). Sorry.
- 24 Excuse me.
- 25 (Discussion off the record, 10:45 a.m. to
