- 2 CHAIRMAN CATANACH: Good morning. This is
- 3 a meeting of the New Mexico Oil Conservation Commission.
- 4 My name is David Catanach. I'm chairman of the
- 5 Commission. The time is 9:00 a.m. Today's date is July
- 6 13th, 2017. This meeting is being conducted in Porter
- 7 Hall within the Wendell Chino State Building.
- 8 At this time I will take roll, and I'll ask
- 9 the Commissioners to introduce themselves for the
- 10 record.
- 11 COMMISSIONER MARTIN: Ed Martin
- 12 representing the State Land Office.
- 13 COMMISSIONER BALCH: Dr. Robert Balch,
- 14 designee of the Secretary of Energy, Minerals and
- 15 Natural Resources.
- 16 CHAIRMAN CATANACH: Thank you, gentlemen.
- 17 Also present today is Mr. Bill Brancard,
- 18 who will be sitting in as Commission attorney.
- 19 And also present is Ms. Florene Davidson.
- 20 Commissioners, in your packet today, you
- 21 should have an agenda for today's meeting. If you've
- 22 review the agenda, do I hear a motion and a second to
- 23 adopt the agenda?
- 24 COMMISSIONER BALCH: I've reviewed the
- 25 agenda, and I would move to adopt it.

Page 3 1 COMMISSIONER MARTIN: I agree with it and 2 second. 3 CHAIRMAN CATANACH: All in favor? (Ayes are unanimous.) 4 5 CHAIRMAN CATANACH: Motion to adopt today's agenda is passed. 6 7 Also in your packet are the draft minutes 8 from the June 13th, 2017 Commission meeting. 9 Commissioners, I'd ask you if you've reviewed the 10 minutes, do you have any changes to the minutes, and, if 11 not, is there a motion and a second to adopt the 12 minutes? 13 COMMISSIONER MARTIN: I have reviewed them. I have no changes, and I move to adopt. 14 COMMISSIONER BALCH: And I second. 15 16 CHAIRMAN CATANACH: All in favor? 17 (Ayes are unanimous.) 18 CHAIRMAN CATANACH: Motion to adopt the 19 minutes from the June 13th Commission meeting is passed. 20 (The proceedings conclude, 9:02 a.m.) 21 (12:13 p.m.) 22 CHAIRMAN CATANACH: Do we need to do a 23 litigation update? 24 MR. BRANCARD: Oh, yes. 25 So just briefly on litigation, we now have

- 1 four appeals sitting in district court.
- 2 CHAIRMAN CATANACH: Nice.
- 3 COMMISSIONER BALCH: Is that a new record?
- 4 CHAIRMAN CATANACH: Are we doing something
- 5 right here or what?
- 6 MR. BRANCARD: Well, part of it is lack of
- 7 decision-making by the district court.
- 8 So we have the geothermal case, which I
- 9 filed a motion to dismiss for, and we had a hearing on
- 10 that last December. They have not ruled yet.
- 11 CHAIRMAN CATANACH: Oh, wow.
- 12 MR. BRANCARD: So that's still sitting
- 13 there.
- 14 Then there is the Jalapeno-Matador case.
- 15 That has been fully briefed. As part of the briefing
- 16 filed by Matador, they filed motion to dismiss several
- 17 of the issues that Jalapeno had raised. The Court had
- 18 set a hearing in November on the case, but because
- 19 Matador was the only one who asked for the hearing, the
- 20 hearing is only on the motion to dismiss. It's not on
- 21 the full case. But I will anticipate, going into the
- 22 hearing, the Court will want to hear the whole thing.
- 23 CHAIRMAN CATANACH: Hmm.
- 24 MR. BRANCARD: The two more recent cases
- 25 are the LES appeal of the 2K [sic] permit. So we've

1 gotten the record in on that case this last week. And

- 2 so LES will have their brief due by early August, and
- 3 then we'll have to follow 30 days later with our brief
- 4 in that case.
- Now, the fourth case -- it was just filed
- 6 yesterday -- was filed by COG in that case you had with
- 7 them.
- 8 CHAIRMAN CATANACH: Nearburg.
- 9 MR. BRANCARD: Nearburg, right. But their
- 10 lawyers, in fact, were here today, and they informed me
- 11 that this is kind of just a placeholder appeal, that
- 12 they're trying to work it out, and they're going to try
- 13 to submit something with the Court staying the case. So
- 14 we don't have to file the record right away.
- 15 COMMISSIONER MARTIN: Better late than
- 16 never?
- MR. BRANCARD: Yeah.
- 18 CHAIRMAN CATANACH: Okay. I gotcha.
- 19 COMMISSIONER BALCH: I don't think they
- 20 have much of a negotiating place.
- 21 MR. BRANCARD: So that's where we are with
- 22 litigation.
- COMMISSIONER BALCH: As long as it's not
- 24 more Pit Rule stuff, I'm happy.
- 25 CHAIRMAN CATANACH: Well, there were a

1 couple of controversies in that case. There are some

- 2 rule changes coming up. I don't know exactly when.
- 3 COMMISSIONER BALCH: Those negotiations
- 4 will be for the next Commission.
- 5 CHAIRMAN CATANACH: That's true.
- 6 MR. BRANCARD: And even in the district
- 7 court. They go on for years.
- 8 COMMISSIONER BALCH: We've only got another
- 9 year and a half to go. We can certainly last that long.
- 10 MR. BRANCARD: I wouldn't be surprised with
- 11 the Jalapeno-Matador case, the hearing -- punt it up to
- 12 the Court of Appeals. He can do that on his own, given
- that's also the same judge. We haven't had the decision
- in the geothermal case. I guess he's a little busy.
- 15 And the judge who is doing the LES case is about to
- 16 retire. So --
- 17 COMMISSIONER BALCH: Is that going to be
- 18 taken over by -- who is the attorney who was going to
- 19 become appeals court judge?
- 20 MR. BRANCARD: Yeah. He's appeals court.
- 21 All these cases are in the district court, because your
- 22 appeals for adjudicatory matters go to district court.
- We did change the statute so that
- 24 rulemaking appeals now go directly to the Court of
- 25 Appeals. Other matters go just to the district court,

and they get a several-thousand-page record, and they

- 2 don't want to deal with it.
- 3 COMMISSIONER BALCH: I can't say I blame
- 4 them.
- 5 MR. BRANCARD: That's where we are.
- 6 CHAIRMAN CATANACH: Okay. Thanks for the
- 7 update. Thanks for all the work getting the records
- 8 together and stuff.
- 9 MR. BRANCARD: Yeah. Florene has her hands
- 10 full with all that stuff.
- 11 COMMISSIONER BALCH: Our meeting is moved
- 12 to October 5th or moved to October 4th instead?
- 13 CHAIRMAN CATANACH: That's on a Wednesday.
- 14 I don't know what's going on on the docket at this
- 15 point, obviously.
- 16 COMMISSIONER BALCH: Big docket. We have a
- 17 couple of days' drive back and forth to --
- 18 CHAIRMAN CATANACH: We'll shoot for October
- 19 4th. I'll still have to -- I think I'm fine with that.
