- 3 would like to call is Case Number 15414, application of
- 4 RKI Exploration & Production, LLC to re-open Case Number
- 5 15414 to pool the interests of record title owners under
- 6 the terms of Order R-14104, Eddy County, New Mexico.
- 7 Call for appearances.
- 8 MS. KESSLER: Jordan Kessler, from the
- 9 Santa Fe office of Holland & Hart, representing the
- 10 Applicant.
- 11 EXAMINER McMILLAN: Any other appearances?
- 12 Please proceed.
- MS. KESSLER: No witnesses today,
- 14 Mr. Examiners. This will be presented by affidavit.
- 15 And I'll just walk through the affidavit, if that's
- 16 okay.
- 17 EXAMINER McMILLAN: (Indicating.)
- MS. KESSLER: If we look at Exhibit 1, this
- 19 is an affidavit from Mr. Aaron Young. And what RKI is
- 20 requesting in this case is to pool two uncommitted
- 21 record title interest owners who are either unlocatable
- 22 or who have not filed the appropriate paperwork with the
- 23 BLM, so they do not have authority to sign the
- 24 communitization agreement.
- 25 So this case was previously heard before

1 the Division. An order resulted, and that's Order

- 2 R-14104, which is attached as Exhibit A. RKI had
- 3 thought that they were going to be able to obtain the
- 4 signatures of the record title interest owners, but for
- 5 the various reasons that I've explained, they have not
- 6 been able to.
- 7 So what RKI is requesting is that the
- 8 owners on Exhibit B -- this would be the Estate of Joe
- 9 R. Henderson and Estate of H.B. Wigzell, and this has
- 10 since been transferred to the Wigzell 2009 Trust -- that
- 11 those record title interest owners be compulsory pooled.
- 12 As set forth in Exhibit 1, RKI has sent
- 13 communitization agreements to both of the known
- 14 addresses for those interest owners. RKI has tracked
- 15 down the Wigzell Trust, who is the entity that has taken
- 16 over the Wigzell Estate. They have been discussing
- 17 information with them, but Wigzell has not filed the
- 18 appropriate paperwork with the BLM to sign those
- 19 communitization agreements.
- 20 The Estate of Joe R. Henderson has not been
- 21 probated in New Mexico, and there are no heirs in Eddy
- 22 County that RKI has been able to identify. RKI has
- 23 conducted a diligent search of the county records, of
- 24 computer searches and telephone searches and has not
- 25 found anything. Notice of the application has been

1 provided to the known addresses, both of those entities,

- 2 both of those interests.
- A notice of the hearing, which is included
- 4 as Exhibit C, is a copy of the letters that were sent to
- 5 both of those interests by RKI with the communitization
- 6 agreement.
- 7 Exhibit D is the affidavit from my office
- 8 with letters providing the notice of this hearing.
- 9 And then, finally, Exhibit E is the Notice
- 10 of Publication directed, in particular, to Joe R.
- 11 Henderson and his heirs and devisees.
- 12 EXAMINER WADE: And it's all the Eddy
- 13 County, the wells --
- MS. KESSLER: Eddy County.
- 15 So, Mr. Examiners, unless you have any
- 16 questions for me, I would ask this case be taken under
- 17 advisement and that Exhibit 1, including Exhibits A
- 18 through E, be submitted as part of the record.
- 19 EXAMINER McMILLAN: Exhibit 1, A through E,
- 20 shall be accepted as part of the record, and this case
- 21 shall be taken under advisement.
- MS. KESSLER: Thank you.
- 23 (RKI Exploration and Production, LLC
- Exhibit Number 1, A through E, is offered
- and admitted into evidence.)
