- 2 EXAMINER DAWSON: Good morning, everyone.
- 3 Today is October 26th, 2017. It's 8:15 a.m. We're at
- 4 1220 South St. Francis, Santa Fe, New Mexico. We are
- 5 going to cover Docket Number 38-17 today.
- And before I go through the continuances
- 7 and dismissals of the cases, I just want to remind
- 8 everybody that the next hearing will be November 8th,
- 9 which is on a Wednesday. And it's not two weeks from
- 10 today. It's actually one day less than two weeks from
- 11 today. So just to make sure you have your continuance
- 12 and all that -- all your paperwork in at the proper
- 13 time.
- 14 And so now we will go over the case
- 15 continuances and dismissals.
- 16 On page 2 of 12, case number three, which
- 17 is -- Case Number 15858 has been dismissed. Number
- 18 four, Case Number 15859 has been dismissed.
- On page 3 of 12, number nine, Case Number
- 20 15864, that will be -- that will be consolidated in the
- 21 other 12 cases, the Remuda; Purple Sage cases.
- 22 Is that correct, Mr. Feldewert? Is that
- 23 what you guys want to do, consolidate those 12 into one?
- MR. FELDEWERT: Yeah. I think, though, I
- 25 believe --

1 MR. BRUCE: Yeah. Case number nine, 15864,

- 2 Devon Energy, that one will be dismissed.
- 3 EXAMINER DAWSON: Dismissed?
- 4 MR. BRUCE: And that way I think
- 5 Mr. Feldewert can propose consolidating most of the case
- 6 into two separate cases.
- 7 EXAMINER DAWSON: That's okay with you,
- 8 Mr. Feldewert?
- 9 MR. FELDEWERT: Yes. Dismissal of his
- 10 case? Yes.
- 11 (Laughter.)
- 12 MR. FELDEWERT: And we'll able to
- 13 consolidate the other cases.
- 14 EXAMINER DAWSON: So number nine, Case
- 15 Number 15864, will be dismissed.
- 16 Okay. And then we'll go on down to case
- 17 number ten, which is 15865; number 11 on the list, Case
- 18 Number 15866; number 12, on page four, Case 15867; and
- 19 number 13, Case Number 15868, those four cases will be
- 20 continued to November 30th.
- On page 5 of 12, number 18, Case Number
- 22 15844, will be continued to November 8th.
- On page 6 of 12, Case number 25, which is
- 24 Case Number 15782, is continued to December 21st.
- Going to page 7 of 12, number 26, Case

- 1 Number 1587 -- 15783 is continued to December 21st.
- 2 Number 27, Case Number 15755, is continued to November
- 3 30th. Number 28, Case Number 15773, and number 29, Case
- 4 Number 15774, are both continued to November 30th.
- 5 That takes us to page 12 of 12, Case Number
- 6 15855, which is number 44 on the list, will be continued
- 7 to Tuesday, November 7th.
- 8 Are there any other continuances or
- 9 dismissals that I didn't catch there that you guys are
- 10 aware of?
- 11 MS. KESSLER: Mr. Examiner, page number 5,
- 12 case number 17, which is 15872, has been amended. It
- 13 will be heard on the November 30th docket.
- 14 EXAMINER DAWSON: Okay. Case number five,
- 15 Number 15860, continued to -- which date? I'm sorry.
- 16 MS. KESSLER: No. It's Case Number 15872,
- 17 number 17 on page 5.
- 18 EXAMINER DAWSON: Oh, okay. Okay.
- 19 Continued to what date? I'm sorry.
- MS. KESSLER: November 30th.
- 21 EXAMINER DAWSON: Okay. So case number 17,
- 22 on page 5 of 12, which is Case Number 15872, will be
- 23 continued to November 30th.
