STATEMENT OF THE CASE

APPLICANT

Case 15949: Applicant seeks a 143.56-acre non-standard spacing and proration unit (project area) in the Bone Spring formation comprised of Lots 1-4 (the W/2W/2) of Section 18, Township 21 South, Range 33 East, NMPM, and the pooling of all mineral interests in the Bone Spring formation. The unit is dedicated to the Sombrero Fed. Com. Well No. 501H, a horizontal well with a surface location in Lot 4 of adjoining Section 7, and a terminus in Lot 4 of Section 18.

Case 15950: Applicant seeks a 160-acre non-standard spacing and proration unit (project area) in the Bone Spring formation comprised of the E/2W/2 of Section 18, Township 21 South, Range 33 East, NMPM, and the pooling of all mineral interests in the Bone Spring formation. The unit is dedicated to the Sombrero Fed. Com. Well No. 503H, a horizontal well with a surface location in the SE/4SW/4 of adjoining Section 7, and a terminus in the SE/4SW/4 of Section 18

Case 15951: Applicant seeks a 160-acre non-standard spacing and proration unit (project area) in the Wolfcamp formation comprised of the E/2W/2 of Section 18, Township 21 South, Range 33 East, NMPM, and the pooling of all mineral interests in the Wolfcamp formation underlying. Also to be considered will be the cost of drilling and completing the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.
