13 MR. BRUCE: Mr. Examiner, Jim Bruce  
14 entering an appearance for Devon Energy Company, L.P. I  
15 have no witnesses.

16 EXAMINER McMILLAN: Please proceed.

17 MS. KESSLER: Mr. Examiner, these cases  
18 were heard in October on a special docket and taken  
19 under advisement at that time. Again, following the
