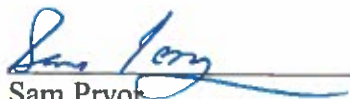

Sam Pryor, being first duly sworn on oath, states as follows:

1. My name is Sam Pryor and I am employed by Matador Production Company ("Matador") in Dallas, Texas, as a manager of federal lands. I previously testified as an expert in petroleum land matters in Case No. 15747 that resulted in the issuance of pooling Order R-14432 on September 1, 2017.
2. Division Order R-14432 created an approximately 155.29-acre spacing and proration unit consisting of the N/2 S/2 of Section 19, Township 20 South, Range 29 East, NMPM, in Eddy County, New Mexico and pooled the uncommitted interests in this spacing and proration unit. This unit was to be initially dedicated to Matador's proposed **Stebbins 19 Federal Com No. 133H** (API No. 30-015-44174), a horizontal well to be drilled from a surface location 2347 feet from the South line and 520 feet from the East line (Unit I) to a bottom hole location 1870 feet from the South line and 240 feet from the West line (Lot 3) of Section 19. This well has been drilled but not yet completed.
3. Matador has now proposed to all of the interest owners to change the surface location and target of the initial well within the Bone Spring formation. The revised surface location is 2317 feet from the South line, 520 feet from the East line (Unit I) to a standard bottom hole location 1870 feet from the South line, 240 feet from the West line of Section 19. The well will target a shallower depth within the Bone Spring formation.
4. In addition, Matador has changed the name of the proposed well from Stebbins 19 Federal Com No. 133H to the **Stebbins 19 Federal Com No. 123H** (API No. 30-015-44170).
5. Attachment A to this affidavit is a copy of the well proposal letter and authorization

for expenditure (AFE) that was provided to all of the interest owners in the spacing and proration unit. The well proposal letter and AFE reference the revised surface hole location, TVD, and well name.

MRC Delaware Resources, LLC and its operating company Matador Production Company (collectively "MRC") propose the drilling of the Cueva De Oro 21 Federal #123H well (the "Well"), located in the W2E2 of Section 21, Township 20 South, Range 29 East, Eddy County, New Mexico, to test the Bone Spring formation. The estimated cost of drilling, testing, completing, and equipping the Well is \$6,972,965, as itemized on the enclosed Authority for Expenditure ("AFE") dated June 19, 2017.

The Well will be drilled to a total vertical depth of 7,910' and a total measured depth of 12,656', producing a treatable lateral of approximately 4,632' within the Bone Spring formation to be completed.

MRC is proposing to drill the Well under the terms of a modified 1989 AAPL form of Operating Agreement ("OA") covering 160 acres, being the W2E2 of Section 21, Township 20 South, Range 29 East, Eddy County, New Mexico from the surface to the base of the Bone Spring formation ("Contract Area") pursuant to the following terms:

- 100/300/300% Non-consent penalty
- \$7,000/\$700 Drilling and Producing overhead rate

MRC requests that you indicate your election to participate in the drilling and completion of the Well in the space provided below, sign and return one (1) copy of this letter along with your geological well requirements, the AFE, and the OA to the undersigned.
