Boyle & Company of Marathon Oil Permian, LLC's application to re-open Case No. 15594 for a non-standard oil spacing and proration unit and compulsory pooling, Eddy County, New Mexico, The State of New Mexico, through its Oil Conservation Division, hereby gives notice that the Division will conduct a public hearing at 8:15 a.m. on November 8, 2017, to consider this application. Applicant seeks an amended order (1) creating a 480-acre non-standard spacing and proration unit

which covers the SE/4 of Section 25 and E/2 of Section 36, both located within Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico; and (2) pooling all uncommitted mineral interests in the Wolfcamp formation underlying this non-standard spacing and proration unit. This proposed spacing and proration unit will be the project area for the Southern Comfort 25-36 State X Well No. 1H and 2H wells to be drilled horizontally. The producing areas for these wells will be orthodox. Also to be considered will be the cost of drilling and completing said well, the allocation of these costs as well as the actual operating costs and charges for supervision, designation of Marathon Oil Permian, LLC as operator of the well, and a 200% charge for risk involved in drilling said well. Said unit is located approximately 10 miles southwest of Carlsbad, New Mexico.
