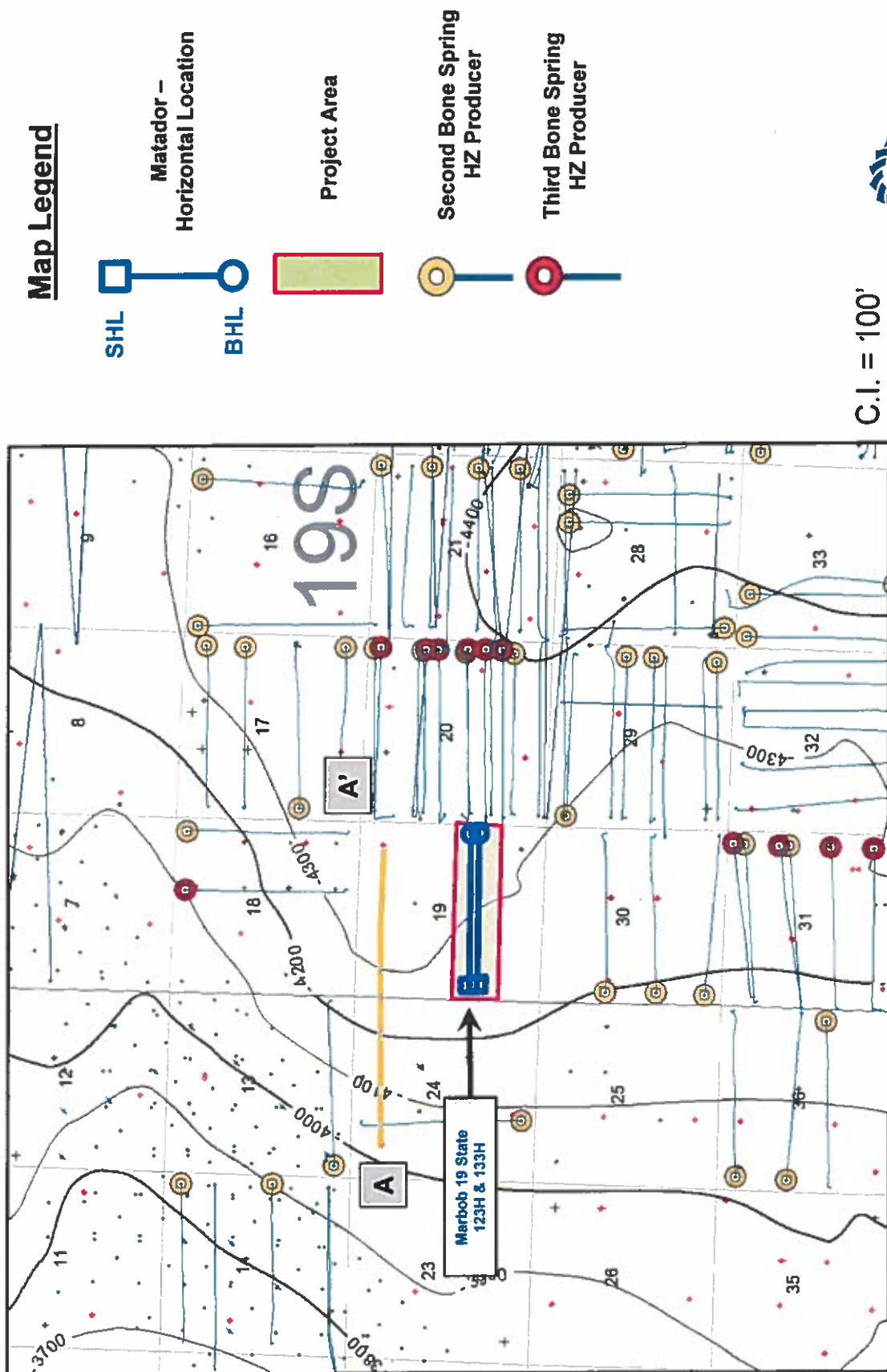

Scanlon Draw; Bone Spring (Pool Code: 55510) Isopach Map (First Bone Spring – Base Third Bone Spring Sand)

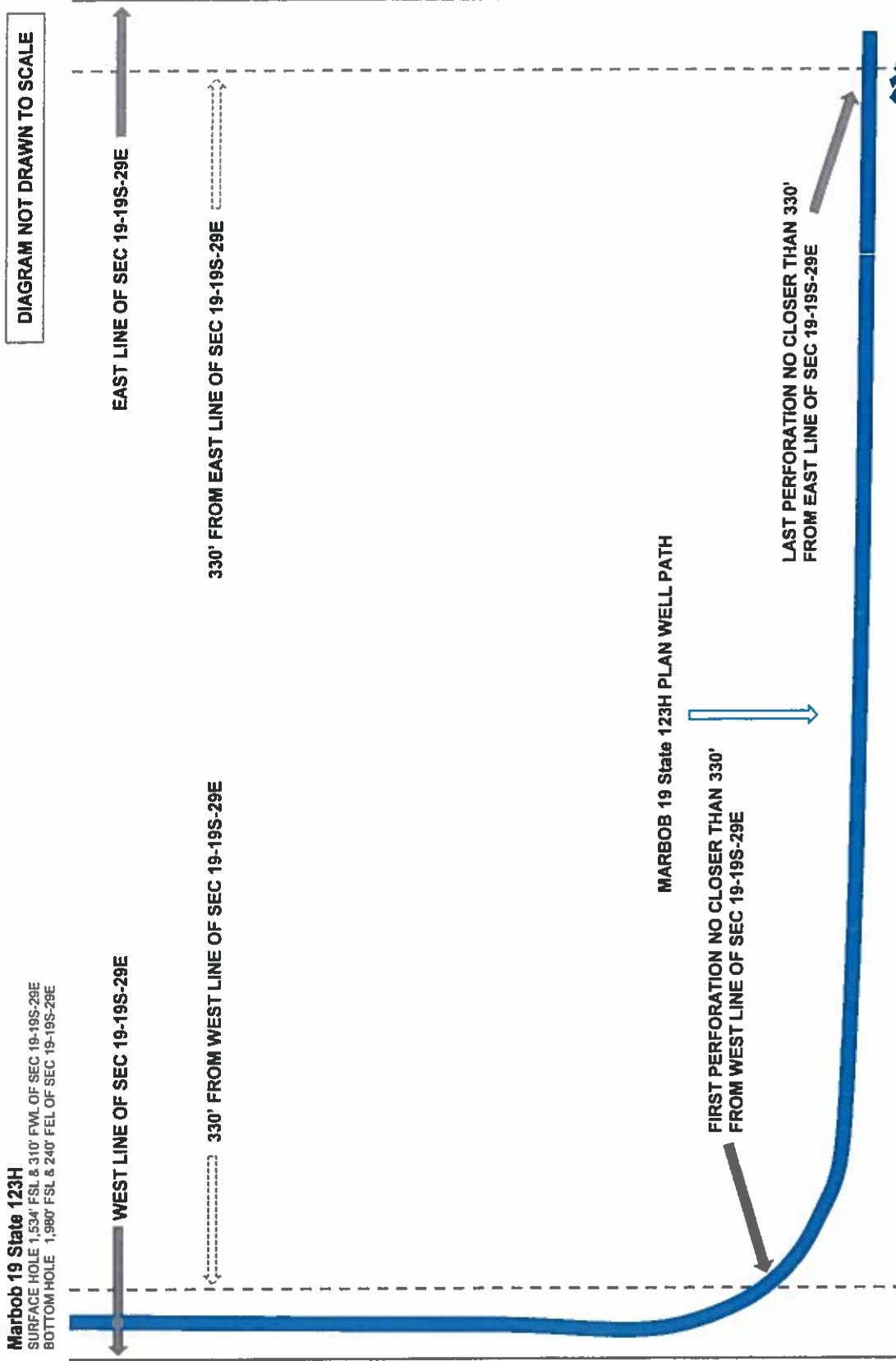

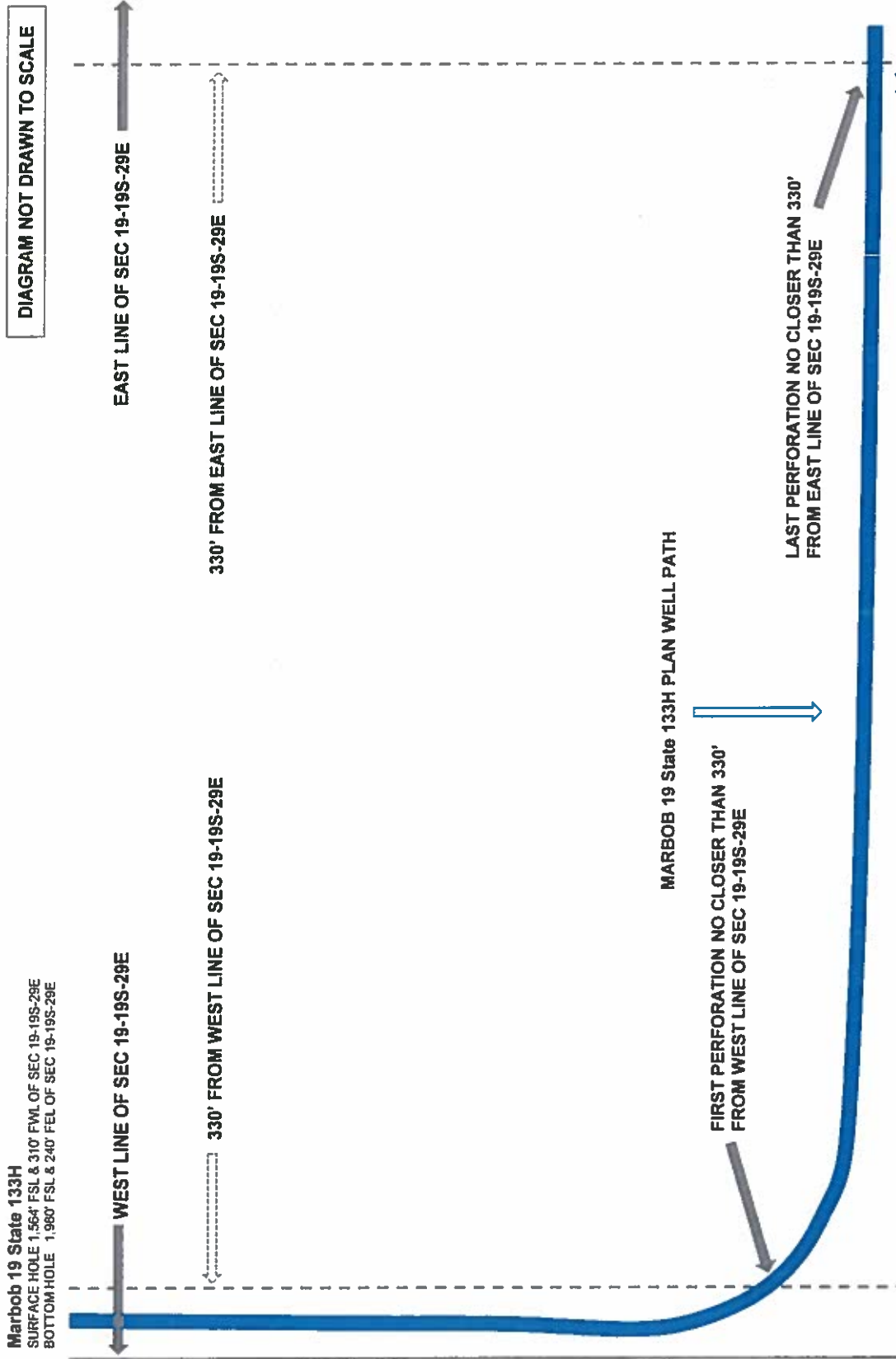
