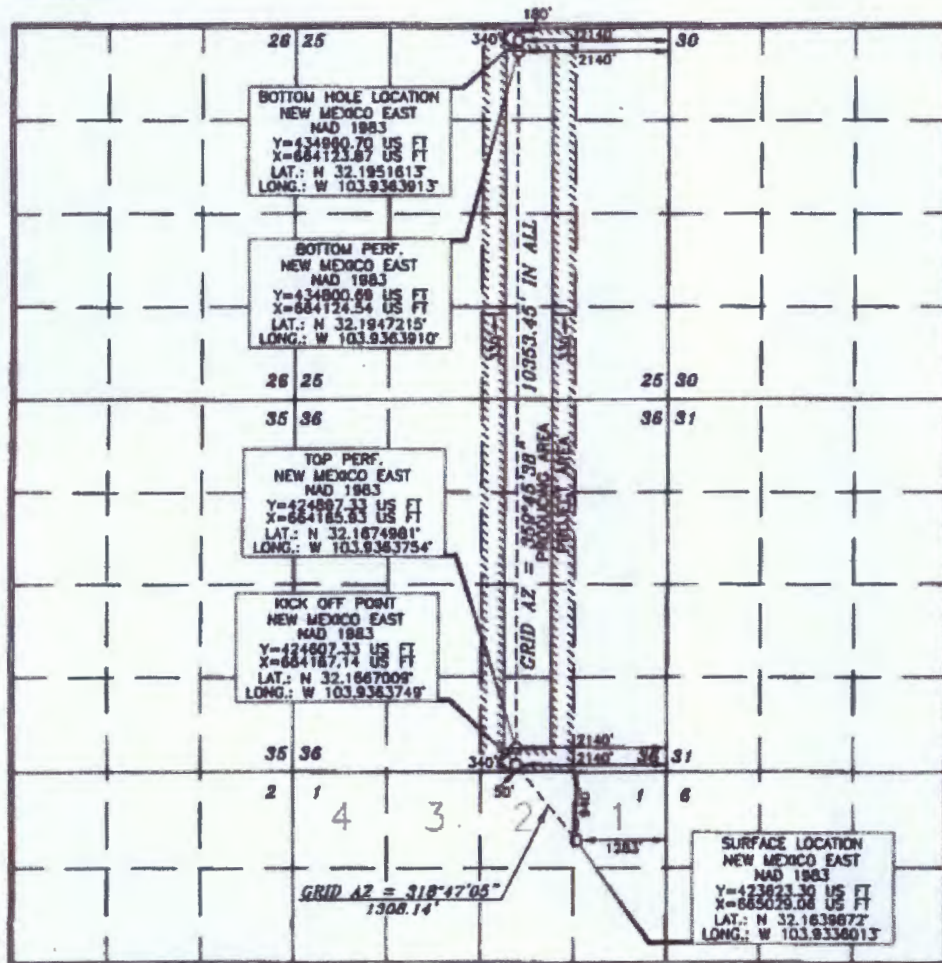

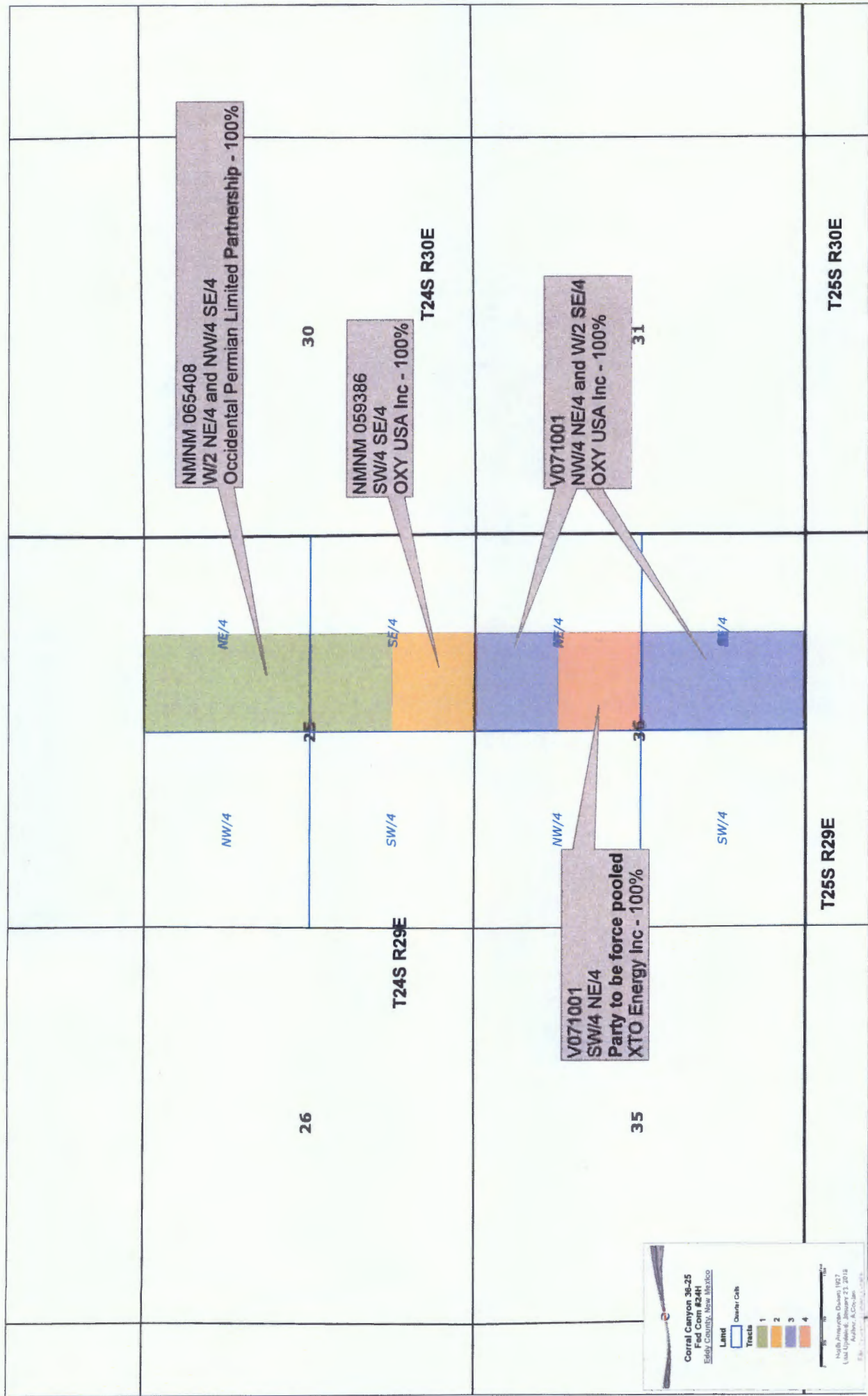

OXY USA Inc. ("OXY") hereby proposes the drilling of the Corral Canyon 36-25 Fed Com #24H well at the referenced surface location in Section 1-25S-29E to its terminus at the referenced bottom hole location in Section 25-24S-29E, Eddy County, New Mexico. The proposed horizontal well will be drilled to an approximate vertical depth of 9,018', and to an approximate measured depth of 19,193' to evaluate the Second Bone Spring formation. A detailed description of the total estimated cost to drill and complete the well is set out in the enclosed AFE.

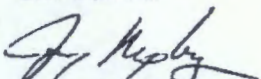

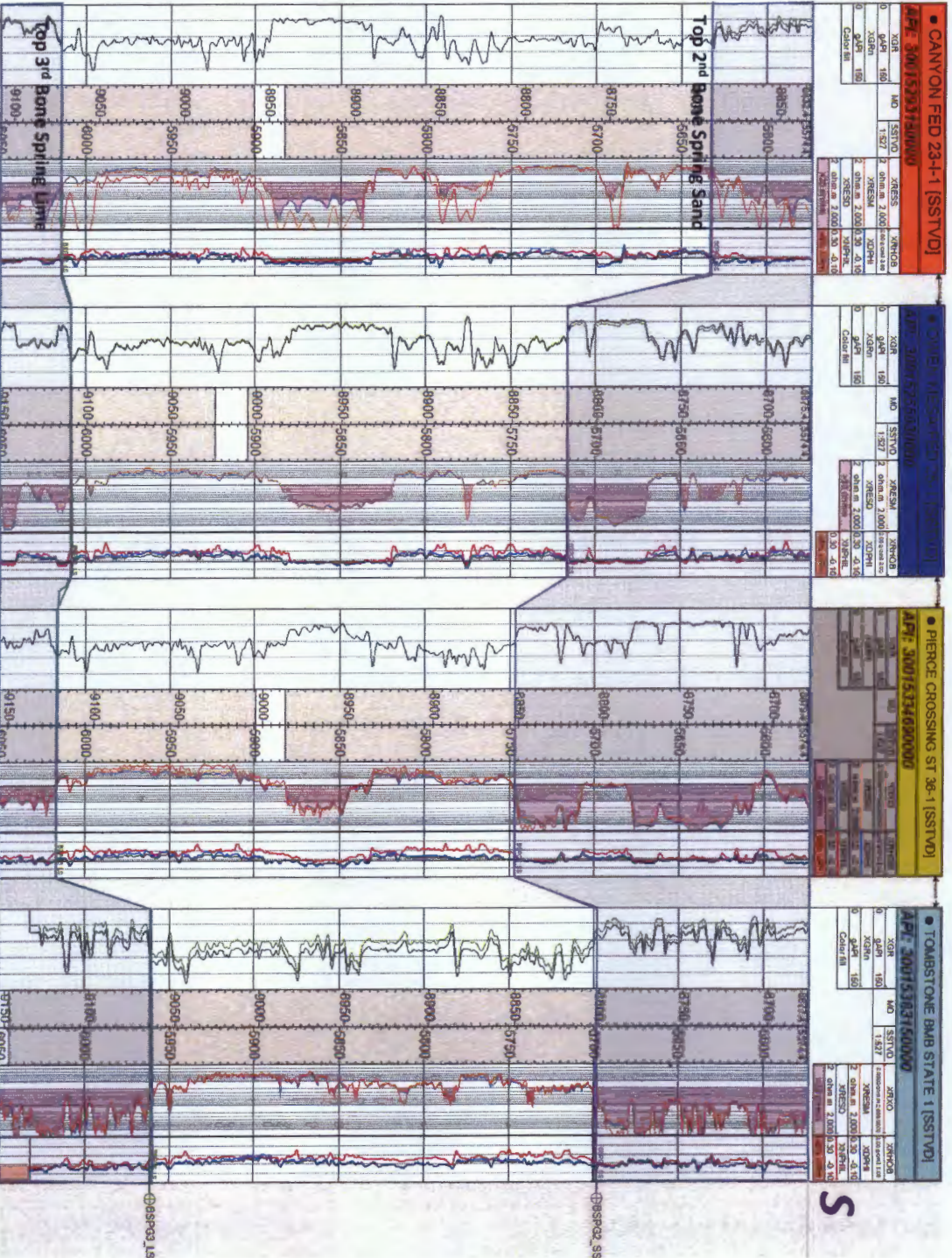


▲ Structural Control Points
