OPPONENT CIMAREX ENERGY CO.

In Case Nos. 15998, 16016-16018, Centennial Resources Production, LLC has requested the creation of four non-standard proration units for development within Section 18, Township 21 South, Range 33 East, NMPM, Lea County New Mexico to accommodate the drilling of the Horseshoe Fed. Com Well Nos. 601H, 602H, 701H, 7012H.

Cimarex is the lessee of record for the E/2 of Section 7, Township 21 South, Range 33 East. It objects to any development plans offered at hearing by Centennial Resources with proposed off-lease surface locations, located on acreage that is leased to Cimarex, because such locations will impair Cimarex's correlative rights and cause waste.
