APPLICANT'S STATEMENT OF CASE

Chisholm Energy Operating, LLC ("Chisholm") seeks an order (1) creating a 638.16-acre, more or less, non-standard spacing and proration unit comprised of the W/2 of Section 3 and the W/2 of Section 10, Township 24 South, Range 26 East, NMPM, Eddy County, New Mexico; and (2) pooling all uncommitted interests in the Wolfcamp formation underlying this acreage. Chisholm proposes to dedicate the above-referenced non-standard spacing and proration unit as the project area for its proposed Black River 3-10 Fed Com WCA No. 2H Well, its proposed Black River 3-10 Fed Com WCA No. 3H Well, and its proposed Black River 3-10 Fed Com WCA No. 4H Well. The three proposed horizontal wells will be pad drilled from a surface location in the NE/4 NW/4 (Lot 3) of Section 3 to standard bottom hole locations in the SW/4 SW/4 (Unit M) and the SE/4 SW/4 (Unit N) of Section 10. The completed intervals for these wells will remain within the 330-foot offset as required by the special rules for the Purple Sage-Wolfcamp Gas Pool adopted under Division Order R-14262.
