APPLICANT'S STATEMENT OF CASE

Matador seeks an order from the Division pooling all uncommitted interests in the Wolfcamp formation underlying the 320.79-acre, more or less, spacing and proration unit comprised of the S/2 of Section 20, Township 20 South, Range 29 East, NMPM, Eddy County, New Mexico. Matador proposes to dedicate the above-referenced spacing and proration unit as the project area for its proposed **Stebbins 20 Fed No. 204H Well**, which will be horizontally drilled from a surface location in the SW/4 SW/4 (Unit M) to a non-standard bottom hole location in the SE/4 SE/4 (Unit P) of Section 20. The completed interval for this well is unorthodox

pursuant to the Division Statewide Rules for gas wells; however, the Division has previously authorized the unorthodox location under Administrative Order NSL-7615.


