- 2 EXAMINER DAWSON: Okay. Back on the
- 3 record.
- 4 And at this point, we want to go to case
- 5 number 40 on the list, which is Case Number 16024, and
- 6 case number 41 on the list, which is Case Number 16076.
- 7 We have some supplemental exhibits that need to be
- 8 presented on these cases. And I'll go ahead --
- 9 Jennifer, do you want --
- 10 MS. BRADFUTE: Jennifer Bradfute on behalf
- 11 of Marathon Oil Permian LLC.
- 12 I'll let Michael go ahead.
- MR. FELDEWERT: Michael Feldewert, from the
- 14 Santa Fe office of Holland & Hart, appearing on behalf
- 15 of BTA.
- 16 EXAMINER DAWSON: Okay. Case Number 16024
- 17 is an amended application of BTA Oil Producers, LLC for
- 18 a nonstandard spacing and proration unit and compulsory
- 19 pooling in Eddy County, New Mexico.
- Go ahead, Ms. Bradfute.
- 21 MS. BRADFUTE: Jennifer Bradfute on behalf
- of Marathon Oil Permian LLC, Mr. Examiner.
- 23 EXAMINER DAWSON: Okay. Any other
- 24 appearances on that case?
- Okay. Go ahead.

1 MS. BRADFUTE: Mr. Examiner, these two

- 2 cases were heard during a special docket on April 24th
- 3 by Mr. Jones and Mr. Brooks. At the conclusion of that
- 4 hearing, the parties agreed in both cases, 16024 and
- 5 16076, that additional notice needed to be provided.
- 6 Marathon published notice in a newspaper of
- 7 general circulation, and then additional certified
- 8 mailings were sent out to the lessor. Marathon has an
- 9 exhibit to add in its case, 16076, which confirms that
- 10 that notification was provided. There is an Affidavit
- of Publication from a newspaper of general circulation,
- 12 as well as return receipt confirmation.
- 13 At this point in time, Marathon asks that
- 14 this exhibit be admitted into the record.
- 15 EXAMINER DAWSON: Okay.
- MR. FELDEWERT: No objection.
- 17 EXAMINER DAWSON: No objection?
- MR. FELDEWERT: Mr. Examiner, we also have
- 19 an exhibit we need to introduce in Case 16024.
- 20 EXAMINER DAWSON: Okay. So at this point,
- 21 on Case Number 16076, which is an application of
- 22 Marathon Oil Permian LLC, compulsory pooling, Eddy
- 23 County, New Mexico, we have a supplemental exhibit that
- 24 was provided to us from Ms. Bradfute, and it is Exhibit
- 25 Q. Is it all of Exhibit Q?

- 1 MS. BRADFUTE: It is.
- 2 EXAMINER DAWSON: And there is no objection
- 3 to admitting Exhibit Q to Case Number 16076?
- 4 MR. FELDEWERT: No, sir.
- 5 EXAMINER DAWSON: Okay. So at this point,
- 6 Exhibit Q will be admitted to Case Number 16076.
- 7 (Marathon Oil Permian LLC Exhibit Letter Q
- 8 is offered and admitted into evidence.)
- 9 EXAMINER DAWSON: This case will be
- 10 continued?
- MS. BRADFUTE: Yes. Mr. Examiner, we ask
- 12 this case be continued to the May 31st docket.
- 13 EXAMINER DAWSON: Case 16076 will be
- 14 continued to May 31st.
- 15 We'll bounce back to 16024, Mr. Feldewert.
- 16 MR. FELDEWERT: Yes, sir. This case, along
- 17 with the previous case you just discussed, was heard on
- 18 April 24th as competing Wolfcamp well proposals, which
- 19 involve the Purple Sage Gas Pool, which is 320-acre
- 20 spacing units. BTA's development plan is essentially a
- 21 mile and a half. Marathon's is a mile. To establish
- the spacing unit for the mile-and-a-half unit, BTA asked
- 23 in its application to create a nonstandard 160-acre
- 24 spacing unit in the northwest quarter of 32 to marry
- 25 with the west half of Section 29, to come up with the

1 480-acre spacing unit for a mile-and-a-half well. The

- 2 south half of Section 32 is dedicated to a Wolfcamp
- 3 spacing unit for wells that are being drilled by
- 4 Mewbourne.
- 5 At the time of the hearing, therefore, BTA
- 6 notified the interest owners in the northeast quarter of
- 7 Section 32 and not the southwest quarter of Section 32
- 8 because the acreage had been dedicated already to a
- 9 south-half Wolfcamp spacing unit.
- 10 Mr. Brooks raised concerns about the way --
- 11 we should have notified the interest owners in the
- 12 southwest quarter. And he will acknowledge, I guess,
- 13 there is a debate between perhaps himself and Mr. Bruce
- 14 and maybe myself as to whether that actually has to
- 15 occur. But putting that aside and not wanting that to
- 16 become an issue in this case, we've gone ahead and
- 17 notified the interest owners of the southwest quarter of
- 18 32 for purposes of giving them notice of the creation of
- 19 that nonstandard unit.
- 20 So I'd like to introduce BTA Exhibit 21,
- 21 because there were 20 BTA exhibits admitted back on
- 22 April 24th, so if I may approach. BTA Exhibit 21 is a
- 23 notice affidavit providing notice to those mineral
- 24 owners in the southwest quarter of Section 32 so that we
- 25 don't have any concerns over whether or not they should

- 1 be notified. Okay?
- 2 EXAMINER BROOKS: You will be glad to know
- 3 that the new horizontal well rule will eliminate this --
- 4 will eliminate that applicability of that particular
- 5 provision to nonstandard horizontal spacing units.
- 6 MR. FELDEWERT: I am well aware of that and
- 7 look forward to that day. But we're not there yet, so
- 8 that's why --
- 9 EXAMINER BROOKS: I do, too.
- MR. FELDEWERT: That's all I have,
- 11 Mr. Examiner.
- 12 EXAMINER DAWSON: Are there any objections?
- MS. BRADFUTE: No. There are no
- 14 objections.
- 15 EXAMINER DAWSON: Okay. So at this point,
- 16 Exhibit 21 will be admitted to the record on Case Number
- 17 16024.
- 18 (BTA Oil Producers, LLC Exhibit Number 21
- is offered and admitted into evidence.)
- 20 MR. FELDEWERT: And likewise, that case, by
- 21 prior agreement and email you sent that week, will be
- 22 continued to May 31st to accommodate Marathon's
- 23 additional witnesses who are going to present testimony.
- 24 EXAMINER DAWSON: Okay. Case Number 16024
- 25 will be continued to May 31st.

Page 8 MR. FELDEWERT: Thank you. EXAMINER BROOKS: I should not have even mentioned that because you probably know more about the horizontal well than I do at this point. MR. FELDEWERT: I don't know about that, but at least we'll get this issue out of the way. EXAMINER BROOKS: I'm very glad we're going to. (Case Numbers 16024 and 16076 conclude.)
