Mr. Herrmann,

We appreciate your granting our firm a two week extension on the scheduled hearing date for the above captioned case. I have attached several documents for your information. All have been submitted to the respective regulatory authorities.

The production reporting OGOR for the periods of 04/18, 05/18, and 06/18 which show that the Teas Yates #112, API 30-025-28032 and the Teas Yates #012, API 30-025-28027 have been placed back into service and have been in production for in excess of a period of 90 days. The placing of these two wells into active injection and production should bring our company into compliance with 19.15.5.9(A)(4) AND 19.15.25.8 NMAC and NMSA 197,:70-2-14. We only have two shut in wells currently, which meets the required maximum for operators of less than 50 wells, the category in which our company falls.

I have also enclosed the C-103 for the approved plugging procedure for the State 12-1. As I told you yesterday, we have awarded this plugging bid to Basic Well Service. They have indicated that the well should be plugged within the next few weeks. As soon as it is plugged, we will submit the proper forms and forward same to your office.

Finally I have enclosed the original approved C-103 on the Skelly D-5 to T/A the well pending a casing integrity survey. We have conducted the survey, and have elected to permanently plug and abandon this well. Attached is the recently submitted plugging procedure for C-103 for the Skelly D-5. We have not awarded this bid as of today. We anticipate having Basic Well Service complete this work, but it would be premature to seek a bid for plugging operations until those procedures we have submitted have been approved. Once they have been approved, we will forward the approved C-103 on this well and schedule the plugging operations.

We appreciate your consideration in this matter. We will keep you apprised to our progress to plug and abandon these two shut in wells which will result in our company having 0 temporarily abandoned or shut in wells.
