**Subject:** Bone Yard Fee 16H Central Tank Battery - Objection

All: I represent Dan Evans Sheehan, Charles M. Thompson, Lois Thompson, Doda S. White, Harvey D. Sheehan and Dan Cody Keefe (the "Sheehan Family Members"). They have recently received a commingling application from COG Operating LLC for the Bone Yard Fee 16H Central Tank Battery, which involves a request to commingle production from the following wells:

- Bone Yard Fee 11H (API 30-015-43417)
- Bone Yard Fee 12H (API 30-015-43305)
- Bone Yard Fee 16H (API 30-015-43999)

The Sheehan Family Members have overserved several discrepancies in overriding royalty payments received from COG and object to this application. They believe that the commingling of production will only compound these issues, leading to further accounting and production confusion concerns. The Sheehan Family Members are in the process of reaching out to COG and hope to resolve these concerns. However, they ask that the Division not grant this application until their objections can be resolved.
