3 go down to Case Numbers 16265 and 16266. I'm supposing
4 these two will want to be consolidated, correct?

5 MS. KESSLER: That's correct.

6 EXAMINER DAWSON: Okay. Case Number 16265,
7 number 37 on the list, is an application of Centennial
8 Resource Production, LLC for a nonstandard spacing and
9 proration unit and compulsory pooling, Lea County, New
10 Mexico, and Case Number 16266 is also an application of
11 Centennial Resource Production, LLC for a nonstandard
12 spacing and proration unit and compulsory pooling, Lea
13 County, New Mexico.

14 Ms. Kessler, when you're ready.

15 MS. KESSLER: Mr. Examiner, Jordan Kessler
16 from Holland & Hart on behalf of the Applicant.

17 MR. BRUCE: Mr. Examiner, Jim Bruce of
18 Santa Fe representing ConocoPhillips Company.

19 EXAMINER DAWSON: Okay.

20 MS. KESSLER: No witnesses today,
21 Mr. Examiner.

22 This case was heard two weeks ago and
23 continued for two reasons. The first was because this
24 was filed before June 26th and, therefore, not subject
25 to the updated horizontal well rule, so we did have to

1 notify offsets, and we had requested an additional two
2 weeks for that notice to be perfected.

3 EXAMINER DAWSON: Okay.

4 MS. KESSLER: The second reason,
5 Mr. Examiners, was to allow additional time for
6 Centennial and the Baird Trust to negotiate an
7 agreement. I have an email here from Ms. Sharon
8 Shaheen, who represented Weldon Baird, and this states
9 that Weldon Baird did lease his interest to another
10 party who Centennial is now negotiating an operating
11 agreement with.

12 EXAMINER DAWSON: Okay.

13 MS. KESSLER: I'll just mark this as
14 Exhibit Z and give it to the court reporter,
15 Mr. Examiner.

16 Mr. Examiner, I would move admission of
17 Exhibit Z and ask that the case be taken under
18 advisement.

19 EXAMINER DAWSON: Exhibit B?

20 MS. KESSLER: Z, as in zebra.

21 EXAMINER DAWSON: Oh, Z, as in zebra.
