2 EXAMINER McMILLAN: Good morning. I'd like
3 to call to order Docket Number 37-18. Today's date is
4 September 6th, 2018. The time is 8:15 a.m. My name is
5 Michael McMillan. I will be the hearing examiner. To
6 my left is Attorney David Brooks. And for two of the
7 cases, we are going to have other examiners.
