
NATURE OF INTERVENOR'S INTEREST

In Case No. 16443 NGL Water Solution Midstream, LLC ("NGL") seeks approval to inject produced water into the Siluro-Devonian formation through the Sidewinder SWD Well No. 1, located in Section 10, Township 25 South, Range 34 East, NMPM.

Solaris has applied for administrative injection authority for its Telluride Fed. SWD Well No. 1, which is within 1.5 miles of the Sidewinder well. Thus, Solaris is an interested person in this case.

Moreover, NGL has objected to Solaris' above-noted administrative SWD application. See Exhibit 1. NGL also requested that the Solaris application be set for hearing. As a result, Solaris will file a motion for continuance so that all related cases may be heard together.


