**REQUEST FOR CONTINUANCE OF NOVEMBER 1, 2018 HEARING**

Cimarex Energy Co. ("Cimarex") respectfully requests a continuance of the hearing in this matter scheduled for November 1, 2018. In support thereof Cimarex states:

1. On October 2, 2018, McElvain Energy, Inc. filed its Application for an order pooling all uncommitted interest in the Bone Spring formation (E-K Bone Spring Pool (Pool Code 21650)) in the 240-acre, more or less, horizontal spacing unit comprised of the W/2 NW/4 of Section 6, Township 19 South, Range 34 East, and the W/2 W/2 of Section 31, Township 18 South, Range 34 East, NMPM, Lea County, New Mexico for its proposed **EK 31 BS2 Federal Com No. 4H** well.

2. Cimarex is in the process of seeking voluntary pooling for a competing well proposal which will enable it to fully develop its 75% working interest in Section 6.

3. Additional time is needed for working interest owners to respond to Cimarex's proposal and to resolve questions concerning the ownership of disputed interest in N/2 of Section 6.

WHEREFORE, Cimarex Energy Co. respectfully requests that this matter be continued on a future Hearing Examiner Docket schedule.
