
NATURE OF INTERVENOR'S INTEREST

In Case No. 16507 NGL Water Solution Midstream, LLC ("NGL") seeks approval to inject produced water into the Siluro-Devonian formation through the Moab SWD Well No. 1, located in Section 24, Township 24 South, Range 33 East, NMPM.

Solaris has applied for administrative injection authority for its Aspen SWD Well No. 1 and Keystone Fed. SWD Well No. 1, which are within 1.5 miles of the Moab well. Thus, Solaris is an interested person in this case.

Moreover, NGL has objected to Solaris' above-noted administrative SWD applications. See Exhibit 1. NGL also requested that the Solaris applications be set for hearing. As a result, Solaris will file a motion for continuance so that all related cases may be heard together.
