STATEMENT OF THE CASE

APPLICANT

Mewbourne Oil Company seeks an order pooling of all mineral interests in the Wolfcamp formation underlying a 640-acre horuizontal spacing unit comprised of the E/2 of Section 1, Township 26 South, Range 29 East, NMPM, and the E/2 of Section 36, Township 25 South, Range 29 East, NMPM. The unit will be dedicated to (i) the Buffalo Trace 1/36 W1PA Fed. Com. Well No. 1H, and (ii) the Buffalo Trace 1/36 W1PA Fed. Com. Well No. 2H. Both wells are horizontal wells with surface locations in the NE/4NE/4 of adjoining Section 12, first take points in the SE/4SE/4 of Section 1, and final take points in the NE/4NE/4 of Section 36. Also to be considered will be the cost of drilling and completing the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as

operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.
