STATEMENT OF CASE

In Case No. **16284** Novo seeks an order creating a 160.36-acre standard horizontal spacing and proration unit in the Bone Spring formation underlying the Lot 1 (NE/4NE/4), SE/4NE/4 and E/2SE/4 of Section 5, Township 23 South, Range 29 East, Eddy County, New Mexico. Applicant further seeks the pooling of all uncommitted mineral interests in the Bone Spring formation underlying this acreage. This 160.36-acre standard unit is to be dedicated to the applicant's **Rana Salada Fed Com 05 124H well** which will be horizontally drilled from a surface location in the NE/4NE/4 of Section 5, Township 23 South, Range 29 East, to a bottom hole location in the SE/4SE/4 of Section 5, Township 23 South, Range 29 East. The completed interval will be orthodox.
