STATEMENT OF THE CASE

Devon Energy Production Company ("Devon") seeks an order (1) creating to the extent necessary a standard 320-acre, more or less, horizontal spacing and proration unit ("HSU") comprised of the E/2 E/2 of Sections 16 and 21, Township 25 South, Range 32 East, NMPM, Lea County, New Mexico, and (2) pooling all uncommitted interests in the Bone Spring formation (WC-025 G-06 S253206M; BONE SPRING [96715]) underlying the HSU. Devon proposes to dedicate the above-referenced 320.00 acre spacing and proration unit as the standard horizontal

spacing and proration unit for its proposed **Marwari 28-16 State Fed Com 238H well**, to be horizontally drilled from an approximate surface location 175' FNL and 925' FEL of Section 28 to a bottom hole location 330' FNL and 660' FEL of Section 16. This well defines the HSU.
