





1. I am over the age of 18, I am a petroleum geologist for Devon Energy Production Company L.P. ("Devon") and have personal knowledge of the matters stated herein. I have previously been qualified by the Oil Conservation Division ("Division") as an expert petroleum geologist.
2. **EXHIBIT A** is a structure map on the base of the 2nd Bone Spring in the area of the proposed well. The proposed spacing and proration unit is identified by the black outline. The proposed horizontal locations are identified by a blue line, and the proposed well is identified by the red line.
3. Exhibit A identifies wells completed in the 2nd Bone Spring in the vicinity of the proposed well, and has a line of cross-section running from A to A'.
4. Exhibit A shows that the structure dips east -- southeast.
5. **EXHIBIT B** is a stratigraphic cross-section which run from A to A'. The well logs on the cross-section give a representative sample of the 2nd Bone Spring in the area. The target

zone for the well is the 2nd Bone Spring, identified by the words "Producing Zone" and the shaded area across the cross-section. That zone is relatively continuous across the unit.

6. **EXHIBIT C** is a Gross Interval Isopach of the 2nd Bone Spring. The 2nd Bone Spring gross interval is relatively uniform with good thickness across the proposed well unit.









Structure Map


