- 2 EXAMINER DAWSON: Moving on down the list,
- 3 we're going to number eight on the list at this time,
- 4 which is Ameredev Operating, LLC for compulsory pooling.
- 5 This is amended and readvertised, and it's for the Pine
- 6 Straw Fed Com 25 36 08 #101H.
- 7 Call for appearances.
- 8 MS. BROGGI: Julia Broggi, with Holland &
- 9 Hart, on behalf of the Applicant, Ameredev Operating,
- 10 LLC.
- 11 EXAMINER DAWSON: Do you have any
- 12 witnesses?
- MS. BROGGI: No. We're going to be
- 14 presenting these cases by affidavits.
- 15 EXAMINER BROOKS: What is the case number
- 16 in this case?
- 17 EXAMINER DAWSON: The case number in this
- 18 case is 16395. It's number eight on the docket.
- 19 EXAMINER BROOKS: Oh, I see it's on here,
- 20 Case 16395.
- 21 EXAMINER DAWSON: These are consolidated,
- 22 16394 and 16395. Let me find out where 16394 is.
- MS. BROGGI: I can help you with that.
- 24 EXAMINER WARNELL: Page 5?
- MS. BROGGI: Yes. It's case 67 on page 5.

1 EXAMINER DAWSON: 16349 is also the Pine

- 2 Straw Federal Com 25 36 8 #91H, and 16395 is the Pine
- 3 Straw Federal Com 25 36 8 #101H. So these two will be
- 4 consolidated.
- 5 MS. BROGGI: Thank you.
- And we are presenting these by affidavits.
- 7 So Exhibit A is an affidavit from the
- 8 landman. And as you noted, these cases were amended and
- 9 readvertised. Both case numbers, 16394 and 16395, were
- 10 originally presented by affidavit on September 6th,
- 11 2018. But since then, Ameredev filed amended
- 12 applications to include proximity tracts in the spacing
- unit, so that's why we're re-presenting the case today.
- In Case Number 16394, Ameredev is seeking
- 15 to pool all of the uncommitted mineral interests in the
- 16 Bone Spring Formation underlying the approximately
- 17 640-acre spacing unit comprised of the west half-west
- 18 half of Section 5 and the west half-west half of Section
- 19 8, the east half-east half of Section 6 and the east
- 20 half-east half of Section 7, Township 25 South, Range 36
- 21 East, Lea County, New Mexico. And we are seeking to
- 22 dedicate the spacing unit to the proposed Pine Straw Fed
- 23 Com 25 26 08 #91H well.
- 24 EXAMINER BROOKS: And where is the -- where
- 25 is the C-102?

1 MS. BROGGI: They are both -- for that

- 2 case, that's attached as Al to the affidavit of the
- 3 landman, and that's a revised C-102.
- 4 EXAMINER BROOKS: Okay.
- 5 MS. BROGGI: And then in the second case,
- 6 Case Number 16395, Ameredev is seeking to pool all
- 7 uncommitted mineral interests in the Wolfcamp Formation
- 8 underlying the approximately 640-acre spacing unit
- 9 comprised of the west half-west half of Section 5 and
- 10 the west half-west half of Section 8, the east half-east
- 11 half of Section 6 and the east half-east half of Section
- 12 7, Township 25 South, Range 36 East, Lea County, New
- 13 Mexico, and seeking to dedicate this spacing unit to the
- 14 proposed Pine Straw Fed Com 25 36 08 #101H well.
- And the C-102 -- the filed C-102 is
- 16 attached as Exhibit A2 to the affidavit of the landman.
- 17 We've also attached land exhibits for each
- 18 of the cases, and those are Exhibits A3 and A4. Those
- 19 show the tracts of land and the ownership interests, and
- 20 they identify the parties that Ameredev is seeking to
- 21 pool in both of these cases. And as you will see in the
- 22 affidavit, these are both working interest owners and
- 23 unleased mineral interest owners.
- 24 A well-proposal letter was sent to both the
- 25 working interest owners and the unleased mineral

1 interest owners. So for Case 16394, that's found at

- 2 Exhibit A5, and there is an AFE included with that. And
- 3 then the well-proposal letter for the second case, Case
- 4 Number 16395, that's found at Exhibit A6, and that
- 5 includes an AFE as well.
- 6 Ameredev has made an estimate of overhead
- 7 and administrative costs. That's 7,000 a month for
- 8 drilling and 700 a month while producing, and they ask
- 9 that these figures be incorporated into any order.
- 10 There are also no depth severances in
- 11 either of these formations with respect to these cases.
- 12 And then finally, Ameredev provided the
- 13 names and last known addresses of the pool parties to
- 14 our law firm. And while not all parties were locatable,
- 15 we did publish notice, and that can be found in
- 16 affidavit -- sorry -- Exhibit D, which is the Notice of
- 17 Publication.
- 18 And then Exhibit C is an affidavit from our
- 19 office showing evidence that notice of the hearing was
- 20 mailed out.
- 21 And Exhibit B is the affidavit of the
- 22 geologist. Amending these applications did actually
- 23 change the exhibits -- the geology exhibits, but the
- 24 geologist did execute a second affidavit and
- 25 reincorporated the corresponding geology exhibits, and,

1 again, you know, testified that in his opinion drilling

- 2 would be the most efficient method to develop this
- 3 acreage and in the best interest of conservation, the
- 4 prevention of waste and the protection of correlative
- 5 rights.
- 6 EXAMINER DAWSON: Okay. Thank you.
- 7 Mr. Brooks, do you have any questions?
- 8 EXAMINER BROOKS: No questions.
- 9 EXAMINER DAWSON: Mr. Warnell?
- 10 EXAMINER WARNELL: No questions.
- 11 EXAMINER DAWSON: Ms. Murphy?
- 12 EXAMINER MURPHY: Are these stacked?
- MS. BROGGI: Oh, yes. They are stacked,
- 14 because one is targeting the Bone Spring. That is the
- 15 first case, I believe, and then the second case is
- 16 targeting the Wolfcamp.
- 17 EXAMINER MURPHY: Okay. Thank you.
- MS. BROGGI: And if there are no further
- 19 questions, we would ask that Case Numbers 16394 and
- 20 16395 be taken under advisement.
- 21 EXAMINER DAWSON: Okay. At this point
- 22 16394 and 16395 will be taken under advisement.
- Thank you very much.
- MS. BROGGI: Thank you very much.
