Page 3 HEARING EXAMINER: We will call -- will we 1 combine the next two cases? 2 MR. BRUCE: Yes. 3 HEARING EXAMINER: Case Number 20279 and 20280, 4 5 Ascent Energy LLC for compulsory pooling, Eddy County. б MR. BRUCE: Mr. Examiner, Jim Bruce of Santa Fe 7 representing the applicant. I'm submitting this case by affidavit. 8 MS. BROGGI: And Julia Broggi of Holland & Hart 9 on behalf of XTO Energy Inc. and no objection to publication 10 by affidavit. 11 MR. BRUCE: Mr. Examiner, I handed you a set of 12 13 exhibits. Exhibit 1 is the affidavit of Lee Zink, Ascent's landman. They are seeking to force pool -- in Case 20279, 14 they are seeking to force pool the Bone Spring Formation. 15 16 In Case 20280 they are seeking to force pool the Wolfcamp Formation. Both well units are the S/2 S/2 of 17 Section 23 in the S/2 S/2 of Section 24, 20 South, 30 East. 18 If you go through the exhibits, this is part of a 19 proposed federal potash development area shown on Attachment 20 A. Attachment B is the well unit. Attachment C is proposal 21 letter which was sent, oh, five or six months ago. 22 23 Attachment D contains the affidavit or -- excuse me -- AFEs for the three wells, that is the 501H -- Red 24 Hornet 501H Well is the Bone Spring, the 601H, which is a 25

Page 4 Bone Spring well, I believe the Third Bone Spring, and then 1 the 701H well, which is the Wolfcamp well. 2 3 The affidavit contains the usual information. The only party being forced pool is XTO Holdings LLC. They 4 5 own a 12.5 percent working interest in the various wells and б in the well units. The AFEs are stated to be fair and reasonable. 7 Ascent is requesting 7500 a month for a drilling 8 well and 750 a month for a producing well. And they also 9 request the cost plus 200 percent risk charge. 10 I understand the parties are negotiating for a trade or something like 11 that, but at this point we still need to force pool them. 12 13 Exhibit 2 is the affidavit of notice for these hearings, and XTO did receive actual notice. 14 And then Exhibit 3 is the affidavit of William 15 16 Metz, also called Ben Metz, and he has information on the Second Bone Spring Sand, which is the 501H Well in the Third 17 Bone Spring Sand, which is the 601H Well, and then the 18 Wolfcamp, which is the 701H Well. 19 Each of the packages as to each zone contains a 20 21 structure map, a cross-section showing the targets for the wells, and also as to each well there is production data 22 23 from wells in the area, Second, Third and Wolfcamp. So I'm 24 -- there are a number of Bone Spring wells out here, and the production data from the Wolfcamp is kind of sparse, to say 25

There is only one recent well, and that was 1 2 drilled by Madagar. 3 The affidavit states that each quarter-quarter section in the well units will contribute more-or-less 4 5 equally to production for each respective zone. And there is no faulting or other problem which would impair the 6 7 drilling of the wells in this area. 8 With that, I move the admission of Exhibits 1 9 through 3 and ask that these cases be taken under 10 advisement. 11 MS. BROGGI: No objection. 12 HEARING EXAMINER: No objection. Exhibits 1 13 through 3 will be accepted and will be taken under 14 advisement for this case. 15 I have one question for you. On your verified statement for Ben Metz, on the top portion it says -- it 16 identifies the same case number twice. Is that just an 17 18 error? MR. BRUCE: You know what, that should be -- I 19 20 meant to correct that. The second one should be 280. 21 HEARING EXAMINER: 280, okay. 22 Any questions? 23 MR. JONES: No. 24 HEARING EXAMINER: Mr. Brooks? 25 MR. BROOKS: No questions.
