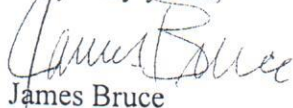
Ladies and gentlemen:

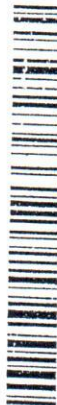
