Vou are asking for data from 1/1/2002 to 4/1/2005 as missing from the flood.

I found storage reports for this project dating back to Oct 2003 – so we may be missing 2002 and the first 10 months of 2003.

But we will continue to look and will examine our process to ensure better data retention.

The OCD has scanned in your gas storage reports into the related Case files for the case that permitted the storage project. We also sometimes store the data in specific Well Files.

We have had some flooding (Harvey) and lost some files in the process however I don't know if we ever actually had the data by well for that period.

We file the attached report with your agency monthly.

If we could get our hands on those reports for the periods above, we would have exactly what we need. The wells in question are all included on that sheet. We have looked multiple times through the website and find those reports sporadically, but have not found the reports for the dates we need.
